Action

I. Election of Chairman (and Deputy Chairman)

The Subcommittee deliberated (index of proceedings attached at **Annex**).

2. Mr LEUNG Yiu-chung, member who had the highest precedence in Council among members of the Subcommittee present, presided over the election of Chairman. Mr LEUNG advised that the prorogation of the Sixth Legislative Council ("LegCo") would start from 18 July 2020. As a presiding member did not have the power to adjourn the election of Chairman, he sought members' views on whether the election should continue.

3. Ms Tanya CHAN and Mr IP Kin-yuen considered it impractical for the elected Chairman, if any, to commence the work of the Subcommittee given the limited time left in the current LegCo term. Also, the Panel on Education had discussed the development of textbooks and teaching materials for kindergartens, primary and secondary schools on 3 July 2020. Mr CHAN Chi-chuen, Dr Helena WONG and Mr HUI Chi-fung shared a similar view that it was not practical to continue the election.

Action

4. Ms YUNG Hoi-yan, Mrs Regina IP, Mr CHAN Chun-ying, Ms Elizabeth QUAT, Mr CHEUNG Kwok-kwan and Mr SHIU Ka-fai expressed great dissatisfaction that Mr LEUNG Yiu-chung, being the presiding member, had not conducted the election effectively. They said that the Subcommittee was set up to address the worries of many parents about biased and inaccurate textbooks and teaching materials. Mr LEUNG Yiu-chung should be held responsible for the Subcommittee's failure in electing Chairman and commencing work.
5. Mr LEUNG Yiu-chung concluded that this meeting was the last Subcommittee meeting. He would not call any meetings of the Subcommittee thereafter.
6. The meeting ended at 10:29 am.
