Proposed timing for discussion

1. Annual tariff reviews with the two power companies

November 2019

Pursuant to the Scheme of Control Agreements signed with the two power companies, the Government will conduct separate tariff reviews with the power companies each year. Thereafter, the two power companies will announce their tariffs for the following year and brief the Panel.

2. Sustainable development of Hong Kong's port and development of high value-added maritime services and the proposal of turning a supernumerary post of Administrative Officer Staff Grade C in the Transport and Housing Bureau into a permanent post

November 2019

At the Panel meeting on 12 October 2017, Hon Claudia MO proposed to discuss the sustainable development of the Hong Kong port.

Hon Holden CHOW Ho-ding wrote to the Panel on 23 October 2018 (LC Paper No. CB(4)108/18-19(01)) requesting to discuss the development of high value-added maritime services.

The Administration will seek the Panel's endorsement on turning a supernumerary post of Administrative Officer Staff Grade C in the Transport and Housing Bureau (which will expire on 31 March 2020) into a permanent post with a view to supporting the development of Hong Kong's maritime industry.

3. Proposal to provide tax incentives for ship leasing

November 2019

The Administration will seek the Panel's endorsement on the proposal to provide tax incentives for ship leasing and ship leasing management business.

4. Statutory cooling-off period for beauty and fitness services consumer contracts

December 2019

The Administration will brief the Panel on the outcome of the public consultation on statutory cooling-off period for beauty and fitness services consumer contracts conducted during January to April 2019, and the legislative proposals to be introduced into the Legislative Council to implement the statutory cooling-off period for beauty and fitness services consumer contracts.

5. Resources proposals relating to the government facilities and equipment to support the three-runway system ("3RS") at the Hong Kong International Airport ("HKIA")

Fourth quarter of 2019

The Administration will seek the Panel's support on the funding application for the government facilities and equipment to support 3RS at HKIA.

6. Proposed creation of two directorate posts in the Air Accident Investigation Authority ("AAIA")

January 2020

The Administration will seek the Panel's endorsement on the creation of one permanent non-civil service post of Chief Accident and Safety Investigator (D2) and one permanent non-civil service post of Deputy Chief Accident and Safety Investigator (D1) to lead AAIA. The existing time-limited post of Chief Accident and Safety Investigator will expire on 31 March 2020.

7. Hong Kong Tourism Board Work Plan for 2020-2021

February 2020

The Hong Kong Tourism Board will present its work plan for 2020-2021, and brief the Panel on the overview of Hong Kong tourism industry in 2019 and the outlook of 2020.

8. Update on Hong Kong Disneyland Resort

February 2020

Representatives of the Hong Kong Disneyland will update the Panel on the operations of Hong Kong Disneyland Resort for the fiscal year 2019.

9. Legislative amendments to implement the latest requirements under conventions of the International Maritime Organization ("IMO")

February 2020

The Administration will seek Panel's endorsement on the following latest requirements of IMO —

- (i) permission to use electronic record books mandated under Annexes I, II and V of the International Convention for the Prevention of Pollution from Ships;
- (ii) Energy Efficiency Design Index (EEDI) regulations for ice strengthened ships; and
- (iii) ban on the carriage of non-compliant fuels on board ships.

10. Report on the work of the Competition Commission

First/second quarter of 2020

The Competition Commission will brief the Panel on its work since the last report in April 2019 and to provide an outlook for the coming year.

11. Update on the development of 3RS at HKIA

April 2020

The Airport Authority Hong Kong ("AAHK") will provide an update on the developments of the 3RS project.

12. The Hong Kong International Aviation Academy

Second quarter of 2020

AAHK will brief the Panel on the developments of the Hong Kong International Aviation Academy.

13. Amendments to the Hong Kong Civil Aviation (Investigation of Accidents) Regulations (Cap. 448B)

The Administration will seek the Panel's endorsement on the second phase legislative amendments to the Hong Kong Civil Aviation (Investigation of Accidents) Regulations (Cap. 448B) with a view to incorporating the latest requirements for and the manner of conducting investigation of aircraft accidents or serious incidents promulgated by the International Civil Aviation Organization.

14. Implementation of the Trade Descriptions (Unfair Trade Practices) (Amendment) Ordinance 2012

The Administration will brief the Panel on the implementation of the Trade Descriptions (Unfair Trade Practices) (Amendment) Ordinance 2012, including that regarding online transactions.

18. Proposed Member's Bill to amend the Electricity Ordinance (Cap. 406)

CB(4)36/17-18(01), CB(4)222/17-18(01) and CB(4)464/17-18(01)) requesting to discuss a proposed Member's Bill to amend the Electricity Ordinance (Cap. 406) to impose restrictions for resale of electricity to a third party, with a view to avoiding landlords of sub-divisions of flat units overcharging their tenants on the use of electricity. The Administration's response is set out in LC Paper No. CB(4)409/17-18(01). Hon LUK Chung-hung reiterated his request for discussion of this subject at the Panel meetings on 22 January and 22 October 2018.
