10. Review of the Sports Subvention Scheme and the governance of "national sports associations"

Hon Andrew WAN raised concerns about the review of Sports Subvention Scheme in his letter dated 13 February 2019 [LC Paper No. CB(2)937/18-19(01)]. The Home Affairs Bureau ("HAB") issued a reply letter on 6 March 2019 regarding the progress of the review and proposing to report the review findings to the Panel in a timely manner [LC Paper No. CB(2)937/18-19(02)].

15. Youth development work

At the meeting on 12 October 2017, Hon IP Kin-yuen proposed to discuss initiatives to promote participation of young people in policy discussion and politics, as well as the funding allocation mechanism for the exchange schemes for the youth in the Mainland and overseas.

At the meeting on 11 October 2018, Hon IP Kin-yuen reiterated his above request. Hon SHIU Ka-chun proposed to discuss the implementation progress of the Youth Hostel Scheme as well as the utilization and management of the Youth Square.

During the policy briefing on the 2019 Policy Address held on 4 November 2019, the Administration briefed members on various new and ongoing youth development initiatives, among other things.

As regards the aforementioned issues raised by Hon IP Kin-yuen and Hon SHIU Ka-chun, HAB has provided detailed response to the Legislative Council ("LegCo") in the past, including the funding allocation mechanism for the exchange schemes for youth in the Mainland and overseas (written reply provided at the LegCo Public Accounts Committee ("PAC") meeting held on 11 July 2018 in response to the relevant recommendations given in Report No. 7 of the Director of Audit, as well as progress subsequently recorded in the Government Minutes of 31 October 2018 for reporting to PAC); implementation progress of the Youth Hostel Scheme [LC Paper Nos. CB(2)1192/17-18(01), CB(2)32/18-19(01) and CB(2)24/19-20(01)]; and utilization and management of the Youth Square (all relevant information is provided in HAB's replies to questions from the LegCo Finance Committee on the examination of Estimates of Expenditure every year).

16. Outcome of the public consultation on the proposed amendments to the Chinese Temples Ordinance

The Panel discussed the outcome of the Review on the Chinese Temples Ordinance (Cap. 153) on 24 March 2015 and held a special meeting on 5 May 2015 to receive public views on the subject. Members noted that the Administration was conducting a public consultation exercise ending on 12 May 2015. The outcome of the public consultation will be considered together with the recommendations of Audit Commission made in Report No. 68 on the management of Chinese temples and comments of the Public Accounts Committee.

To follow up on the review, in 2016, the Chinese Temples Committee established a Review Task Force which would consult various stakeholders when appropriate. HAB will report to the Panel the outcome of the review after concrete discussion results have been achieved.

17. Review of Places of Public Entertainment Ordinance

At the request of the Subcommittee on Places of Public Entertainment (Exemption) (Amendment) Order 2011, the Administration undertook to convey members' concern and suggestions on reviewing the Places of Public Entertainment Ordinance (Cap. 172) ("PPEO"), including narrowing down the scope of "public entertainment" and "place of public entertainment" therein, to the relevant policy bureaux for consideration. The Subcommittee agreed that issues relating to the review of PPEO should be referred to the Panel for follow-up. Members' views and the Administration's response on the subject were detailed in paragraphs 27 and 28 of the Subcommittee's report [LC Paper No. CB(2)1152/11-12].

At the Panel meeting on 10 October 2013, Hon Cyd HO advised that according to a recent ruling of the Court of Appeal, dance performance in the pedestrian precinct did not trigger the licensing requirements under PPEO.

She suggested that the Panel should follow up on issues arising from the court judgment when the review of PPEO was discussed.

At the Panel meeting on 27 February 2017, members agreed to follow up on the issues raised in the submission provided by the Hong Kong Theatres Association Ltd. [LC Paper No. CB(2)852/16-17(01)] regarding the licensing and operation of the cinema industry, which includes a request for review and updating of PPEO.

The case mentioned by the former Hon Cyd HO had been put before the Court of Final Appeal. The Court of Final Appeal's ruling had clarified the interpretation of the definition of "places of public entertainment" in PPEO. Since then, the Government has been issuing Places of Public Entertainment Licences and handling the relevant licensing matters in accordance with the interpretation in the ruling.

The Administration is studying the Hong Kong Theatres Association Ltd's proposal to extend the maximum validity period of the licence and has been in communication with the cinema trade. The Administration will report to the Panel as appropriate when there is specific progress.

18. Public lending right

At the Panel meeting on 24 March 2014, members noted the submission from Hong Kong Public Lending Right Alliance on the introduction of "public lending right" in Hong Kong [LC Paper No. CB(2)1015/13-14(01)]. Members agreed on 11 April 2014 to discuss the subject at a future meeting.

19. Matters relating to the funding for and the governance of major performing arts groups

At the Panel meeting on 24 March 2015, some members expressed concerns about the governance of the Hong Kong Chinese Orchestra. Members agreed that the Panel should discuss the Government's subvention policy for major performing arts groups ("MPAGs") and monitoring of MPAGs' performance in complying with the requirements set out in the Funding and Services Agreements which HAB had entered into with each of the MPAGs.

20. Safety of high-risk sports events

Hon KWONG Chung-yu raised concerns about the safety of high-risk sports events such as boxing in his letter dated 21 February 2017 [LC Paper No. CB(2)873/16-17(01)]. The Administration's reply letter was issued to members on 29 March 2017 vide LC Paper No. CB(2)1089/16-17(01).
