Supplementary information on the sports, recreation and related facility projects (amenity complex in Area 103, Ma On Shan - pre-construction activities; redevelopment of Kowloon Tsai Swimming Pool Complex; and development of open space at Hoi Fai Road, Tai Kok Tsui)

At the meeting of the Legislative Council Panel on Home Affairs held on 20 January 2020, Members requested supplementary information on the sports, recreation and related facility projects (amenity complex in Area 103, Ma On Shan - pre-construction activities; redevelopment of Kowloon Tsai Swimming Pool Complex; and development of open space at Hoi Fai Road, Tai Kok Tsui). Having consulted the Food and Environmental Hygiene Department and the Leisure and Cultural Services Department (LCSD), the relevant information is set out below for Members' reference.

(a) the reason(s) for not providing a public market in the proposed amenity complex in Area 103, Ma On Shan

In considering whether a new public market should be built, the Government will take into account relevant factors including demographic mix, community needs, the availability of public and private market facilities nearby and the number of fresh provision retail outlets in the vicinity. We would also take into account the actual situation of individual districts and the views of stakeholders during

the process.

At present, there are six wet markets managed by various operators, around 20 supermarkets, over 80 fresh provision shops and some 300 licensed food premises in the Ma On Shan district to provide fresh provisions, daily necessities, cooked food, etc. for the local residents. We understand that there will be one more wet market coming into operation within this year, offering more choices for the residents.

Currently, the Government has no plan to build a public market in Ma On Shan.

(b) the number of shortfall of civil service lifeguards and non-civil service contract (NCSC) seasonal lifeguards in the past year

LCSD currently provides lifeguard services at 44 public swimming pools, 38 gazetted public beaches and 5 water sports centres. In addition to civil service lifeguards, NCSC seasonal lifeguards are also employed on a seasonal basis to augment the manpower of lifeguards during the swimming season. As at 1 August 2019, there are 1 843 full-time lifeguards comprising 170 senior lifeguards and 1 673 lifeguards in LCSD. Of those 1 673 lifeguards, 484 are NCSC full-time seasonal lifeguards. Around 190 part-time hourly-rated seasonal lifeguards were also recruited to augment the lifeguard manpower during the swimming season. The establishment, strength and vacancies of civil service lifeguards (including senior lifeguards and lifeguards) and the number of NCSC seasonal lifeguards employed and the number of shortfall of NCSC seasonal lifeguards are at **Annex I**.

(c) the number of days of full closure or partial closure of public swimming pools due to inadequate lifeguards in the past year

For the safety of swimmers, LCSD will take into consideration the usage of swimming pools, swimmers' habits and manpower of lifeguards on duty to partially open swimming pool facilities for use by members of the public, when there are inadequate lifeguards on duty. Generally speaking, major pool facilities, such as main pools and secondary pools will remain open for public use as far as practicable. The numbers of days of full or partial closure of public swimming pools due to inadequate lifeguards on duty over the past year are at **Annex II**.

- * Civil service lifeguards include the grades of Senior Artisan (Beach/Swimming Pool), Senior Artisan (Lifeguard at Water Sports Centre), Artisan (Beach/Swimming Pool) and Artisan (Lifeguard at Water Sports Centre).
- @ Some of the vacancies were non-fillable vacancies as the officers concerned were transferred to other grade/rank on trial terms. In accordance with the practices in the civil service, vacancies arising from transfer of officers could not be substantively filled during the trial period and staff redeployment arrangement will be required, such as filling the vacancies on a temporary basis by NCSC seasonal lifeguards. The remaining fillable vacancies had been filled within a short period of time.

Number of days of full or partial closure of public swimming pools due to inadequate lifeguards on duty in 2019

Some swimming pool facilities will be temporarily fully or partially closed due to inadequate lifeguards on duty. The pool facilities will be re-opened to the public immediately when the manpower of lifeguards returns to normal. For the purpose of calculation, full closure or partial closure of facilities of less than one day is counted as one day.
