## Legislative Council Panel on Home Affairs Community Care Fund

#### Purpose

This paper briefs Members on the work progress of the Community Care Fund ("CCF") and seeks Members' views in this regard.

### Background

2. The CCF is a trust fund established in early 2011 under the Secretary for Home Affairs Incorporation Ordinance (Cap. 1044) with the Secretary for Home Affairs Incorporated as its trustee. Its main objective is to provide assistance to people with financial difficulties, in particular those who fall outside the social safety net or those within the safety net but still have some special circumstances that are not covered. In addition, the CCF may also consider introducing programmes on a pilot basis to help the Government identify those measures that can be considered for incorporation into its regular assistance and service programmes.

3. The CCF has since 2013 been integrated into the work of the Commission on Poverty ("CoP"). The CCF Task Force is set up under the CoP as chaired by the Chief Secretary for Administration. The CCF Task Force, chaired by the Secretary for Labour and Welfare, is responsible for advising the CoP on CCF's various arrangements (including investment, finance and administrative operations, etc.), as well as formulating assistance programmes, coordinating and overseeing the implementation of assistance programmes and evaluating their effectiveness.

4. The Finance Committee ("FC") of the Legislative Council ("LegCo") approved the injection of \$5 billion into the CCF in May 2011. The FC also approved in June 2013 an additional injection of \$15 billion into the CCF to strengthen the poverty alleviation efforts.

### Work Progress

Assistance Programmes

5. Since its establishment, the CCF has launched 57 assistance programmes covering the medical, education, welfare, home affairs and housing areas for various target beneficiary groups including children, elderly persons,

persons with disabilities, patients, new arrivals and ethnic minorities, etc. Its aim is to identify those who cannot benefit from the existing social safety net and to provide them with assistance. The total commitment is about \$17 billion. The CCF programmes have benefitted over 1.77 million cases and the CCF has disbursed around \$8.096 billion<sup>1</sup> to implementing agencies as at the end of April The CCF also implemented measures on a pilot basis to help the 2020. Government identify those initiatives that have been proven effective for incorporation into the regular assistance programmes. The Government so far has incorporated 13 programmes under the CCF into its regular assistance programmes, and plans to incorporate the "Pilot Scheme on Providing Special Subsidy for Persons with Permanent Stoma from Low-income Families for Purchasing Medical Consumables" into the Government's regular assistance programme. Besides, nine programmes were completed. The latest progress of the programmes is set out at the Annex.

6. Since December 2019 when this Panel was briefed on the work progress of the CCF, the CoP has endorsed the launch of the following three new assistance programmes –

- (a) The launch of the "Subsidy for Refurbishment of Property of the MTR Corporation Limited for "T-Home" Transitional Housing Scheme – Trackside Villas" ("the Scheme"): To assist the Hong Kong Housing Society (HKHS) to refurbish Trackside Villas, the property of the MTR Corporation Limited, for transitional housing<sup>2</sup>. The refurbishment works are expected to commence in the second quarter of 2020 in phases and the refurbished flats would be available for intake by eligible applicants in the third quarter of 2020 at the earliest. The Scheme, with a total funding provision of \$45.94 million, is expected to provide at most 252 transitional housing units and benefit around 1 120 persons.
- (b) The launch of the "Living Subsidy for Low-income Households Not Living in Public Housing and Not Receiving Comprehensive Social Security Assistance" Programme (2021) ("the 2021 Programme"): To provide an additional round of one-off living subsidy to those "N-have nots" on top of the living subsidy under the 2020 Programme<sup>3</sup>. The total funding for the 2021 Programme is \$1,447.73 million and it is

expected to benefit about 137 150 households (about 353 600 persons). The 2021 Programme will be implemented in January 2021 following the 2020 Programme of which applications will be accepted in phases from 2 July to 30 November 2020. More than 200 service units operated by non-governmental organisations have been enlisted to assist the "N have-nots" in applying for the subsidy under the above-mentioned Programmes. The subsidy levels of the two Programmes, according to the household size, are the same: \$4,500 for one-person households, \$9,000 for two-person households, \$12,500 for three-person households, \$14,500 for four-person households and \$15,500 for five-or-more-person households.

(c) The launch of the "One-off Allowance for New Arrivals from Low-income Families" Programme ("the Programme"): To provide a one-off allowance of \$10,000 to new arrivals from low-income families who are aged 18 or above and have entered Hong Kong for settlement for less than seven years as at 31 March 2021 to facilitate their integration into the community. The Programme, with a total funding provision of \$2,131.04 million, is expected to be launched and accept applications in around September 2020, and is expected to benefit about 203 000 persons.

7. In addition, through continuous review of existing programmes, the CCF would identify individual programmes that need to be revised or extended in a timely manner so that the assistance being provided can be more appropriate and effective. In this regard, the CoP approved the further extension of the "Subsidy for Comprehensive Social Security Assistance Recipients Living in Rented Private Housing" Programme for six months until end-October 2020. The CoP also endorsed the relief measure<sup>4</sup> under the "Pilot Scheme on Relaxing the Household Income Limit of the Fee-waiving Subsidy Scheme under the After School Care Programme for Low-income Families and Increasing Fee-waiving Subsidy Places" with an aim of sustaining the service provision of the approved service providers under the influence of Coronavirus Disease 2019 (COVID-19).

8. As for the CCF Medical Assistance Programmes, the CoP endorsed the introduction of the drug Dinutuximab Beta for the treatment of neuroblastoma to the "Subsidy for Eligible Patients to Purchase Ultra-expensive Drugs (Including Those for Treating Uncommon Disorders) Programme". Besides, the CCF Task Force Chairperson approved the introduction of seven specified self-financed cancer drugs under the coverage of the First Phase Programme of Medical Assistance Programmes, including one lymphoma cancer drug (Brentuximab

Vedotin), three lung cancer drugs (Brigatnib, Durvalumab, Pembrolizumab), one liver cancer drug (Lenvatinib) and two multiple myeloma drugs (Ixazomib and Lenalidomide), and the relaxation of indication of two existing breast cancer drugs (Palbociclib and Ribociclib), with effect from the second quarter of 2020, in accordance with the streamlined approval process for the introduction of new drugs/medical devices<sup>5</sup>.

### **Financial Position**

9. A total of \$12 billion has been placed with the Hong Kong Monetary Authority<sup>6</sup> (HKMA) to earn investment returns linked to the performance of the Hong Kong Exchange Fund. The remaining funds of the CCF have been placed with banks as Hong Kong dollar time deposit, so as to generate interest income and meet the cash flow requirements of the assistance programmes and other liquidity needs.

10. As at the end of April 2020, the balance of the CCF stood at around \$18.869 billion, consisting mainly of the placement of \$15.301 billion at the HKMA and bank deposits of around \$3.553 billion, with total investment return being \$5.145 billion.

## **Consultation and Monitoring**

11. On consultation work, we plan to conduct four public consultation sessions in late 2020<sup>7</sup> on Hong Kong Island, in Kowloon, New Territories East and New Territories West to collect views on the formulation of new assistance programmes and the work of the CCF from the community and stakeholders, with a view to introducing more appropriate assistance programmes. The CCF

always welcomes members of the public or stakeholders to provide ideas or suggestions through various channels, including the CCF webpage, letters, facsimiles, emails and telephone hotlines. The ideas and suggestions received will be circulated to the CCF Task Force for reference.

12. The CoP and its CCF Task Force will continue to monitor the implementation of various assistance programmes. Government departments and other organisations entrusted to implement the programmes will submit progress and financial reports regularly to the CCF Task Force for a review of the programmes. Before launching any brand-new pilot programmes with an estimated funding provision of over \$100 million, the Government will consult the relevant LegCo Panels. We will continue to report regularly on the financial position of the CCF and the implementation progress of its programmes to this Panel every six months. We will also provide this Panel with evaluation reports of the programmes. Relevant information will be uploaded to the CCF webpage for easy reference by the public.
