#### I. Election of Chairman

Mr CHAN Han-pan and Ms CHAN Hoi-yan were elected Chairman and Deputy Chairman of the Subcommittee respectively.

#### II. Schedule of meetings and items for discussion

- 2. <u>The Subcommittee</u> deliberated (index of proceedings attached at **Annex**).
- 3. The Chairman drew members' attention to the work plan of the Subcommittee endorsed by the Panel on Health Services and said that the Panel had also referred the subject "Update on Chinese medicine development and amendments to the Chinese Medicine Ordinance (Cap. 549)" currently listed on the list of outstanding items for discussion by the Panel to the Subcommittee for follow-up. He remarked that issues relating to the definition and registration of proprietary Chinese medicines should be covered in the discussion of the proposed amendments to the Chinese Medicine Ordinance.
- 4. <u>Members</u> agreed that the Subcommittee should also discuss the following subjects at its future meetings:
  - (a) implementation of the Chinese Medicine Development Fund;
  - (b) progress of introducing Chinese medicine services as part of the medical benefits for civil service eligible persons;
  - (c) safety and quality management of Chinese herbal medicines;
  - (d) role and professional development of Chinese medicine practitioners ("CMPs") in the healthcare system, including the role of CMPs in primary healthcare and the practice of manipulative therapy;

#### Action

- (e) collaboration between Hong Kong and the Mainland, in particular the Greater Bay Area, in the development of Chinese medicine; and
- (f) composition and functions of the regulatory body and advisory committees on Chinese medicine.
- 5. Concluding the discussion, the Chairman said that he and the Deputy Chairman would meet with the Administration to discuss the work plan of the Subcommittee. Members would be informed of the arrangements for the next meeting in due course.
