Legislative Council Panel on Health Services

Prevention and Control of Coronavirus Disease 2019 in Hong Kong

PURPOSE

Further to the submissions to the Legislative Council ("LegCo") and its Panel on Health Services in the past few months¹, this paper provides an update on the Government's response and measures adopted to prevent and control the spread of coronavirus disease-2019 ("COVID-19") in Hong Kong.

LATEST SITUATION

(a) Local situation

2. As at 7 May 2020, Hong Kong had 1 045 confirmed cases (including 1 suspected case), including 4 fatal cases and 943 discharged patients after treatment. Based on epidemiological classification, 648 of them are imported cases or epidemiologically linked with imported cases, 397 are local cases, possibly local cases or epidemiologically linked with local cases.

3. The increase in the number of confirmed cases of COVID-19 in Hong Kong has slowed down in recent days. This reflects that the joint

efforts of the healthcare sector, frontline workers and members of the community since early this year, together with the Government's various public health measures related to social distancing, immigration control and quarantine and testing, are gradually delivering results. There has been no local confirmed case for over two consecutive weeks. There were only 5 imported confirmed cases in the past 4 days, and there were 11 days with no new cases. That said, the outbreak situation remains severe in some overseas countries and regions, and there may still be fluctuations in the outbreak situation in Hong Kong. To safeguard the health of the public and protect Hong Kong's healthcare system, the current focus of the Government's prevention and control work remains to prevent the virus from being imported into Hong Kong from other places and to slow down the spreading of cases in the community.

(b) Global and Mainland situation

4. On 11 March 2020, the World Health Organisation ("WHO") declared that the outbreak of COVID-19 can be characterised as a pandemic. There has been a rapid and continuous increase in the number of confirmed COVID-19 cases reported around the world. As at 7 May 2020 (10 a.m.), besides the Mainland, 216 countries/areas in the world (including Hong Kong) had reported more than 3 544 704 confirmed cases of COVID-19, including more than 252 630 death cases. Please refer to <u>Annex 1</u> for the details.

5. Among these countries/areas, the number of confirmed cases of COVID-19 has been running high in a number of regions, including the United States, Spain, Italy and Germany. As at 7 May 2020, the latest situation in these countries is summarised below –

- (i) United States: The number of confirmed cases reached 1 193 813 (including 70 802 deaths). More than 316 041 of the cases occurred in New York City.
- (ii) **Spain:** The number of confirmed cases reached 220 325 (including 25 857 deaths).

- (iii) Italy: The number of confirmed cases reached 214 457 (including 29 684 deaths).
- (iv) Germany: The number of confirmed cases reached 164 807 (including 6 996 deaths).

6. As for the situation in the Mainland, the number of cases has dropped significantly since early March. The majority of the recent confirmed cases are imported cases. As at 7 May 2020, the cumulative number of confirmed cases reached 82 885 (4 633 deaths), with 68 128 confirmed cases (4 512 deaths) in Hubei Province. For Guangdong Province, the number of confirmed cases reached 1 589 (8 deaths).

KEY MEASURES

7. All government bureaux and departments, the Hospital Authority ("HA"), as well as relevant parties, have stepped up their efforts on all fronts in preventing and controlling COVID-19. An overview of our key measures is set out below. A chronology of major events and measures is at <u>Annex 2</u>.

(a) Strengthening port health measures

8. As an on-going measure, the Government has imposed body temperature checks for all incoming travellers at all boundary control points ("BCPs"). Since 1 February 2020, the Hong Kong International Airport ("HKIA") has implemented body temperature checks for both departing and transit passengers. To strengthen surveillance and contact tracing, a health declaration arrangement has been implemented at HKIA (for Wuhan flights, subsequently all Mainland flights and then Korea flights) and other land-based BCPs since 21 January 2020. With the increasing number of countries/areas reporting community transmission of cases of COVID-19, the Department of Health ("DH") has extended the health declaration arrangement to all inbound travellers at HKIA since DH also started the use of an electronic health 8 March 2020. declaration system at HKIA on the same day. The system has been used by other land-based BCPs since 21 March 2020.

(b) Strengthening immigration control

9. To further prevent imported cases and cut the global and local virus transmission chain as far as possible, the Government has since 25 March 2020 implemented the following measures to restrict entry and suspend all transit services at HKIA, initially until 7 April 2020. Taking into account that the outbreak situation is still severe in some overseas countries and regions, the Government announced on 6 April 2020 to extend the relevant measures until further notice.

- All non-Hong Kong residents coming from overseas countries and regions by plane will be denied entry to Hong Kong;
- Non-Hong Kong residents coming from the Mainland, Macao and Taiwan will be denied entry to Hong Kong if they have been to any overseas countries or regions in the past 14 days;
- > All transit services at HKIA will be suspended; and
- All travellers coming from Macao and Taiwan, including Hong Kong and non-Hong Kong residents, will be subject to a 14-day compulsory quarantine, which is the same as the arrangements for people entering Hong Kong from the Mainland.

10. Taking into consideration the practical situation, a small number of persons can be exempted from the above immigration restrictions and/or quarantine requirements². The Immigration Department will handle each case in accordance with immigration policy, actual situation and established procedures.

⁽a) Crew members of aircraft who need to commute to and from foreign places for performance of necessary duties or crew members of goods vessels;

⁽b) Government officials carrying out government duties including personnel of consular posts; and

⁽c) Personnel engaged in anti-epidemic work endorsed by the HKSAR Government.

(c) Outbound Travel Alerts ("OTAs") and compulsory quarantine

11. In view of the health risks arising from the continuous and rapid increase in the number of COVID-19 cases around the globe, the Government decided on 17 March 2020 to issue the Red OTA on all overseas countries/territories based on public health considerations. Members of the public are strongly urged to adjust their travel plans and avoid any non-essential travel outside Hong Kong.

12. As regards compulsory quarantine, the Government gazetted on 7 February 2020 the Compulsory Quarantine of Certain Persons Arriving at Hong Kong Regulation (Cap. 599C), which mandates all persons having stayed in the Mainland for any period during the 14 days preceding arrival in Hong Kong, regardless of nationality and travel documents used, except for exempted persons, to be subject to compulsory quarantine for 14 days.

13. Having regard to the Red OTA issued on all overseas countries/territories on 17 March 2020, the Government gazetted on 18 March 2020 the Compulsory Quarantine of Persons Arriving at Hong Kong from Foreign Places Regulation (Cap. 599E), which mandates arrivals from all specified places outside China to undergo quarantine. This Regulation took effect on 19 March 2020 at 0:00am and will remain in force for three months till 18 June 2020. The Secretary for Food and Health ("SFH") specified on the same day under Cap. 599E that all persons having stayed in places outside China for any period during the 14 days preceding arrival in Hong Kong, regardless of nationality and travel documents used, except for exempted persons, will be subject to compulsory quarantine for 14 days.

14. Together with the Compulsory Quarantine of Persons Arriving at Hong Kong from Foreign Places Regulation (Cap. 599E) effected on 19 March 2020, the Government gazetted on 24 March 2020 the Compulsory Quarantine of Certain Persons Arriving at Hong Kong (Amendment) Regulation 2020 ("Amendment Regulation"). With effect from 25 March 2020 at 0:00am, the Amendment Regulation extends the compulsory 14-day quarantine arrangement to all persons, except for exempted persons, arriving from or having stayed in Macao and Taiwan in the past 14 days prior to arrival in Hong Kong, in addition to those arriving from the Mainland.

15. To guard against any sudden turn in the outbreak situation in Hong Kong and at the same time allowing the Government to adjust public health measures, the Government gazetted on 28 April 2020 the Compulsory Quarantine of Certain Persons Arriving at Hong Kong (Amendment) (No.2) Regulation 2020 ("the Amendment Regulation No.2"), which took effect on 29 April 2020 at 0:00am. The Amendment Regulation No.2 mainly extends the expiry date of Cap. 599C to 7 June 2020, and provides a legal framework for broadening the exemption of persons or category of persons from compulsory quarantine, so as to allow an orderly relaxation of cross-border activities arising from the need for education or necessary economic activities³, etc. After the amendment, relevant departments can, in accordance with Cap. 599C, seek endorsement from the Chief Secretary for Administration to roll-out exemption mechanisms for exempting the relevant categories of persons. At the same time, the Amendment Regulation No.2 also empowers the Director of Health to, at appropriate time, cancel the quarantine orders against persons arriving from the Mainland or Macao who can fulfill certain criteria and are tested negative for COVID-19.

16. The implementation of the aforementioned border control measures, the Compulsory Quarantine of Persons Arriving at Hong Kong from Foreign Places Regulation and the two Amendment Regulations mean that currently all non-Hong Kong residents arriving from overseas countries or regions are denied entry or transit, and all persons arriving in Hong Kong are required to undergo compulsory quarantine (except for a small number of exempted persons). These measures can further help

prevent the spread of COVID-19 outbreak in Hong Kong.

17. The Government conducts detailed risk assessments prior to implementation of port health measures and quarantine arrangement in response to disease outbreak in other countries or regions. Other than considering the number, distribution and rate of increase of infected persons, the Government would also take into account the surveillance and control measures implemented by the authorities of that particular country/region, as well as the frequency of travels between Hong Kong and that particular country/region. The Government would suitably review and rationalise the relevant measures having regard to the latest development of the outbreak.

(d) Enhancing anti-epidemic facilities and services

Services and facilities of public hospitals

18. In view of the development of the outbreak, the Government and HA have introduced various measures to cope with the demand for services at public hospitals. Triage and test centres have been set up at the Accident and Emergency Departments ("AEDs") of a number of public hospitals to alleviate the demand for isolation facilities at public hospitals. The HA Major Incident Control Centre ("MICC") will liaise closely with DH to triage inbound travellers with upper respiratory symptoms, people undergoing home quarantine or close contacts of confirmed cases, etc. to the AEDs of various public hospitals to undergo testing. Having regard to factors such as service demand and weather conditions, etc., HA will adjust accordingly the arrangement of triage and test centres at AEDs.

19. HA has also retrofitted one to two general wards in each cluster into standard negative pressure wards to provide around 400 additional standard negative pressure beds for patients who are recovering but not yet showing negative results in their virus tests. HA will continue to closely monitor the situation and actively consider different plans for isolation facilities with a view to activating them as soon as possible when the need arises.

Adjustment of HA services

20. In view of the development of the outbreak, HA has significantly adjusted non-emergency and non-essential medical services since 17 February 2020 so as to focus manpower and resources such as personal protective equipment, etc. to provide care for the most critical patients and respond to the epidemic. Specific measures include –

- except for emergency and essential treatment, non-emergency services such as elective surgeries will be postponed;
- specialist outpatient clinics will contact patients with stable conditions to reschedule their appointments and arrange drug refills for them according to their conditions; and
- except for emergency and essential examinations, non-emergency examinations such as routine endoscopy, etc. will be rescheduled.

21. At the same time, HA has expanded the service scope of some of the existing Public-Private Partnership ("PPP") Programmes. Starting from mid-February, the Project on Enhancing Radiological Investigation Services through Collaboration with the Private Sector has expanded its service group to cover all eligible cancer patients. There has also been a significant increase in the service volume of computed tomography scans and magnetic resonance imaging scans. The service quota of the Haemodialysis PPP Programme has also been increased since end-January to refer more patients to community haemodialysis centres for treatment. Furthermore, HA also extended the Colon Assessment PPP Programme in mid-March to cover colonoscopy cases recently delayed due to the epidemic so as to refer suitable patients to receive colonoscopy at private healthcare facilities.

22. HA is also actively liaising with private hospitals to launch new public-private collaboration initiatives, with a view to diverting some patients from public hospitals to private hospitals to receive treatment, such as neonatal jaundice treatment, caesarean delivery, radiotherapy for cancer patients and orthopaedic surgery. Patients can receive early treatment by paying the fees charged by public hospitals. Furthermore,

HA is inviting tender for cystoscopy services. It will refer affected patients by phase to receive the services at private hospitals upon launch of the programme. The arrangement for the provision of relevant services by the private sector will form part of HA's overall strategic service framework for meeting the service demand of patients.

23. On the other hand, HA will change its service model where practicable and continue to serve patients with the use of video conferencing technologies. For example, psychiatric services have piloted the use of telemedicine consultations to provide psychiatric consultation services. Allied health staff have been using video conferences to follow up on treatments, or providing videos of rehabilitation exercises to patients through HA's mobile application "HA Go", so as to allow patients to continue their training at home according to schedule.

24. HA has been closely monitoring the manpower and service situation of public hospitals and making timely adjustments. The industrial action earlier affected public hospital services. At that time, HA activated the MICC to closely monitor the operation of public hospitals and to deploy manpower and adjust non-emergency services with regard to service needs, with a view to ensuring that patients with emergency medical needs will receive proper treatment. With regards to individual affected cases, public hospitals will arrange follow-up consultation or treatment as early as possible in accordance to the patient's situation.

25. As the novel coronavirus outbreak is expected to continue for some time, HA is exploring to gradually resume some of its services where practicable. When considering the resumption of non-emergency and non-essential services, HA will take into account factors such as overall manpower, the stockpile of personal protective equipment as well as infection control measures, etc., and will resume the services by phase. In the first phase, HA will first consider resuming non-emergency diagnostic and check-up services, followed by services that support discharged patients such as outpatient and daytime services in the second phase. The third phase will be the resumption of inpatient services after considering factors such as infection control measures and the safety of patients and healthcare staff, etc. As individual hospitals face different operational environments, they will gradually resume non-emergency services in light of the actual situation and operational need.

District Health Centre Services

26. As the district primary healthcare hub, the Kwai Tsing District Health Centre ("DHC") has been providing community support during the epidemic, such as setting up a community anti-epidemic support hotline, setting up anti-epidemic information centre, as well as distributing anti-epidemic support information and resources, etc. The DHC has also planned to provide multi-disciplinary post-discharge support for patients who have recovered from the novel coronavirus, including services such as pathology explanation, infection control, cardiopulmonary rehabilitation, emotional support, post-recovery nutritional supplement, anti-epidemic drug consultation and restructuring of lifestyle, etc. The Primary Healthcare Office is now discussing with Princess Margaret Hospital on the mode of collaboration. In future, if a doctor considers the condition of a recovered patient to be suitable, he can refer the patient to DHC to join the programme.

Quarantine facilities

27. Currently, there are four quarantine centres for close contacts who may have been exposed to the risk of contracting COVID-19 but are nonetheless asymptomatic, namely the Lei Yue Mun Park and Holiday Village in Chai Wan, the Heritage Lodge at the Jao Tsung-I Academy, Chun Yeung Estate, Fo Tan and the Junior Police Call Permanent Activity Centre ("JPC Centre") at Pat Heung, Yuen Long, providing around 3 700 units in total.

28. In view of the rapid development of the COVID-19 outbreak, it is difficult to accurately estimate the demand for quarantine facilities. Therefore we must be prepared for the rainy days and continue to set up more quarantine facilities where practicable. The Government is continuing to construct at the Sai Kung Outdoor Recreation Centre and at a government site at Penny's Bay through the application of the modular integrated construction method to provide around 900 more quarantine

units in total. It is expected that the units can be completed and put into use from May to July by phase. In addition, the Government will construct quarantine facilities at a site at Penny's Bay reserved for future tourism development, and is preparing to commence the relevant works with an aim to providing 700 more units by September. The Government will closely monitor the latest development and make corresponding deployment in view of the situation.

(e) Enhancing surveillance

29. Under the Enhanced Laboratory Surveillance Programme ("the Programme"), the Center for Health Protection ("CHP") under DH has been providing free testing services for COVID-19 at HKIA to asymptomatic inbound travellers arriving at Hong Kong from places with higher risks since 19 March 2020, with an aim to identifying the patients early and minimising the risk of community transmission. Starting from 29 March 2020, the scope of the Programme has been progressively extended to cover all asymptomatic inbound travellers arriving at HKIA from places under the Compulsory Quarantine of Certain Persons Arriving at Hong Kong Regulation (Cap. 599C) and the Compulsory Quarantine of Persons Arriving at Hong Kong from Foreign Places Regulation (Cap. 599E). To speed up the collection of specimen from inbound travellers from overseas for conducting testing for COVID-19, DH has set up a Temporary Specimen Collection Centre ("TSCC") at Asia World-Expo ("AWE") since 26 March 2020. Starting from 8 April 2020, DH has also strengthened quarantine and virus testing arrangements for inbound travellers, and all persons mentioned above are mandated under the Prevention and Control of Disease Regulation (Cap. 599) to have their deep throat saliva samples collected at the TSCC for conducting testing for COVID-19⁴.

30. To further lower the risks of cases of COVID-19 imported from high risk regions from spreading in the community, starting from 9 April

2020, DH progressively and by phase required all asymptomatic inbound travellers arriving on flights from the United Kingdom, other European countries and the United States to have their deep throat saliva samples collected at DH's TSCC and wait for the test results there. Starting from 19 April 2020, the above measure was extended to all inbound travellers arriving at Hong Kong in the morning, regardless of the place Starting from 22 April 2020, the above measure was of departure. extended to all inbound travellers arriving at Hong Kong. Depending on the arrival time of flights, DH will arrange those asymptomatic inbound travellers who need to wait for test results overnight to be temporarily accommodated in the DH Holding Centre for Test Result set up in a hotel. Besides, in view that in some recent cases persons undergoing home quarantine were tested positive for COVID-19 around the completion date of the quarantine, starting from 20 April 2020, DH provides all asymptomatic inbound travellers arriving at HKIA with an extra specimen collection container and request collection of deep throat saliva samples by themselves on the 12th day of their home quarantine for another round of virus testing.

31. For **land-based BCPs**, starting from 8 April 2020, specimen collection containers will also be provided to inbound travellers who have been to Hubei Province in the past 14 days arriving via Shenzhen Bay Port and the Hong Kong-Zhuhai-Macao Bridge Hong Kong Port for collection of their deep throat saliva samples for virus testing during the period of compulsory home quarantine.

32. At the same time, in order to timely identify and detect cases of novel coronavirus infection transmitted in the community, HA has conducted tests for novel coronavirus infection on all patients meeting the reporting criteria announced by CHP, and gradually extended the scope of surveillance to cover all inpatient pneumonia cases through the Enhanced Laboratory Surveillance Programme ("Surveillance Programme"). Since 19 February 2020, the Surveillance Programme has been further extended to cover outpatients seeking consultation at HA's AEDs or General Out-patient Clinics ("GOPCs") presented with fever and/or respiratory symptoms or mild chest infection. As at 6 May at 7:30 a.m., out of the 1 041 cumulative confirmed cases, 122 were patients seeking consultation at public hospitals' AEDs or GOPCs.

33. As for **private doctors**, starting from 9 March 2020, the Public Health Laboratory Services Branch under CHP provides free virus testing on COVID-19 for relevant samples submitted by private doctors. On 17 April 2020, SFH also issued letters to operators of residential care homes for the elderly and operators/ managers of residential care homes for persons with disabilities, and appealed to them that if an elderly and person with disability is presented with symptoms of fever or respiratory infection, etc., he/she should be arranged to seek consultation as soon as practicable and undergo virus testing for COVID-19 as needed in accordance with the professional assessment of a doctor.

34. Inbound travellers who need to submit samples to DH are required to collect their deep throat saliva samples by themselves at home in accordance with the instructions, and to have their family members or friends deliver the sample to any of the collection points in the same morning the sample has been collected. Starting from 14 April 2020, these people can also make use of a door-to-door specimen collection service provided by member companies of the Cyberport Startup Alumni Association to submit their deep throat saliva specimens to DH for COVID-19 testing. The door-to-door specimen collection service is also provided to relevant private doctors.

(f) Maintaining social distancing to prevent spread of the disease

35. Maintaining social distancing is a key tactic for delaying the spread of COVID-19 in Hong Kong. The Government needs to impose stringent measures, including legislation, to reduce or even prohibit group gathering activities. In accordance with Section 8 of the Prevention and Control of Disease Ordinance (Cap. 599), two additional regulations were made by the Government on 27 March 2020. Details are as follow.

Prevention and Control of Disease (Requirement and Directions) (Business and Premises) Regulation (Cap. 599F)

36. The Government gazetted on 27 March 2020 the Prevention and Control of Disease (Requirement and Directions) (Business and Premises) Regulation (Cap. 599F) to implement temporary measures to address the current situation of public health emergency. Cap. 599F commenced on 28 March 2020 at 0.00 am and will remain in force for three months. It empowers SFH to, having regard to the disease outbreak and overall situation, issue directions through a notice in the Gazette to (a) require catering business premises to cease selling or supplying food or drinks for on-site consumption, and to close whole or part of the premises where food or drink is sold or supplied; (b) restrict the operation of catering business; and (c) restrict the operation of Scheduled Premises. On 1 April 2020, the Government gazetted the Prevention and Control of Disease (Requirement and Directions) (Business and Premises) (Amendment) Regulation to amend the Scheduled Premises under Cap. 599F to 12 categories⁵. In view of the development of the outbreak, SFH had issued various directions at a number of occasions in accordance with Cap. 599F to regulate catering businesses and Scheduled Premises.

37. Considering that Hong Kong's current outbreak situation is relatively stable, the Government should adopt a "suppress and lift" strategy for striking an appropriate balance between the three aspects of public health, economic development and daily operation of society. The Government announced on 5 May 2020 that with effect from 8 May 2020 at 0:00 a.m., some of the social distancing measures would be relaxed as follows. These measures will be effective for 14 days till 21 May 2020.

The number of persons allowed to be seated together at one table at catering business premises (except bars or pubs) is increased from 4 to 8. Other preventive measures previously announced including keeping a distance of at least 1.5 metres between tables or setting up some form of partition as separation, wearing of masks, checking of temperature and provision of hand sanitizer are still required to be implemented. Karaoke activities at catering business premises should continue to be suspended;

- Bars or pubs, and part of a catering business premise that is exclusively or mainly used for the sale or supply of intoxicating liquors for consumption at the premise, are allowed to resume operation. In addition to complying with the above preventive measures applicable to catering business premises, they must restrict the number of customers so that the number does not exceed 50 percent of the normal seating capacity of that premise. Also, no more than 4 persons may be seated together at one table and live performances and dancing must not be conducted in the premises;
- Some Scheduled Premises, including amusement game centres, fitness centres, places of amusement, places of public entertainment, beauty parlours, massage establishments and mahjong-tin kau premises are allowed to resume operation. Club-houses are also allowed to continue to operate. However, they must put in place various preventive measures, including wearing of mask at all times within the premises except specified situations, checking of their body temperature upon people entering the premises and provision of hand sanitisers, etc. When conducting group activities, there can only be 8 or fewer persons in a group, with some form of partitioning between each group. Individual premises must comply with specific measures in accordance with the risk of virus transmission; and
- Other Scheduled Premises, including bathhouses, "party rooms", clubs or night clubs and karaoke establishments are required to remain closed for 14 days till 21 May 2020.

38. The latest details of the various directions issued in accordance with Cap. 599F are set out at <u>Annex 3</u>. Failing to comply with the requirements is an offence and could attract a fine at level 5 (\$50,000) and imprisonment for six months.

Prevention and Control of Disease (Prohibition on Group Gathering) Regulation (Cap. 599G)

39. The Government gazetted on 28 March 2020 the Prevention and

Control of Disease (Prohibition on Group Gathering) Regulation (Cap. 599G). The Regulation commenced on 29 March 2020 at 0.00am and will remain in force for three months.

40. In accordance with Cap. 599G, SFH issued a notice in the Gazette on 28 March 2020 to prohibit group gatherings with more than 4 persons in public places, with effect from 29 March till 11 April 2020, and issued additional directions on 8 and 21 April 2020 respectively, extending twice the effective date of the relevant requirement to 7 May 2020. Having considered that the outbreak situation and the number of confirmed cases have gradually stabilised in the past few weeks, the Government announced on 5 May 2020 to relax the number of persons allowed in group gatherings in public places from 4 to 8, with the effective period being from 8 May to 21 May 2020. The direction also expands the scope of existing exempted group gatherings, including: (i) to cover different functions of the Judiciary; (ii) to increase the maximum number of persons at wedding ceremonies (at which no food or drink can be served) from 20 to 50; and (iii) to cover a shareholders' meeting of a listed company that is held in accordance with any Ordinance or other regulatory instrument that governs the operation of the company or its business. No food or drink can be served at the meeting and there can be no more than 50 persons in a room or partitioned area. Furthermore, to dovetail Cap. 599F and Cap. 599G, gatherings within Scheduled Premises which can be opened according to directions issued under Section 8 of Cap. 599F will not be subject to the restriction on the number of persons in group gatherings (no more than 8 persons) under Cap 599G.

41. Public places mentioned above refer to places where members of the public can get access to from time to time. If certain private properties allow access by members of the public from time to time, such as a shopping mall, such private properties would fall under the definition of public places and the requirements regarding group gatherings will be applicable. In addition, group gathering generally means a group of people who gather for a common purpose. However, there is no hard and fast interpretation of whether a particular group gathering is a group gathering as defined under Cap. 599G. There is a need to look at the actual circumstances of the case and consider all appropriate and relevant

factors, such as whether the gathering is organised beforehand, whether there is any interaction between the participants, and whether the gathering only lasts for a very short period of time.

42. Except for exempted types of group gatherings (please refer to <u>Annex 4</u> for details), any person who participates in a prohibited group gathering; organises a prohibited group gathering; or owns, controls or operates the place of the gathering and knowingly allows the taking place of the gathering, commits an offence. Offenders are liable to a maximum penalty of a fine at level 4 (\$25,000) and imprisonment for six months. Persons who participate in a prohibited group gathering may discharge liability for the offence by paying a fixed penalty of \$2,000.

Enforcement

43. Enforcement work under Cap. 599F and Cap. 599G has been generally satisfactory. With regards to the situation of catering business premises, as at 7 May 2020 at 0:00 a.m., enforcement departments including the Food and Environmental Hygiene Department ("FEHD"), DH, Police and Home Affairs Department had carried out 87 331 inspections with a total of about 3 044 reminders and 61 prosecutions, including 13 cases involving illegal operation of bars and pubs, among which the persons responsible in two cases have been sentenced by the courts to jail for one week and two months respectively. The remaining 48 cases were related to not conducting body temperature screening on customers before their entering the catering business premises and the distance or partitioning between one table and another not being in compliance with the relevant requirements, etc.

44. With regards to Scheduled Premises with restricted operations, law enforcement officers carried out a total of 11 095 inspections. It was found that the industry generally abided by the law. Only around 71 reminders (of advisory nature including immediate rectification) were issued. Three prosecutions involving illegal operation of amusement game centres and two prosecutions involving illegal operation of mahjong-tin kau premises were instituted.

45. As for Cap. 599G, enforcement departments have enhanced

manpower to step up patrols in various public places, and reminded the public to comply with the requirements of the Regulation by verbal explanation, advice or warning. If a person ignores repeated reminders or breaks the law, law enforcement officers also have the responsibility to take enforcement action. As at 7 May 2020 at 0:00 a.m., the Police had handled 5 183 reports on non-compliance of the directions concerned, gave 782 verbal warnings, issued 477 fixed penalty tickets and instituted 15 prosecutions. There is a mechanism under Cap. 599G that allows the person receiving the penalty notice to dispute liability for the offence. The DH, FEHD, Leisure and Cultural Services Department, Housing Department and Agriculture, Fisheries and Conservation Department also looked after public places at the premises under their respective purviews, carried out 68 285 inspections and gave around 11 097 verbal warnings in total.

46. The Government will continue to arrange enforcement and inspection operations to ensure that operators of premises and members of the public will comply with the requirements of the two aforementioned Regulations. We hope to send a strong message to members of the public through legislative work and urge them to be self-disciplined and abide by the law during the effective period of the Regulations. For the sake of themselves as well as other people, they should go out less and avoid social activities such as meal gatherings or get-togethers. They should also maintain proper social distancing as far as possible, with an aim to cutting the virus transmission chain.

(g) Second round of the Anti-epidemic Fund

47. In response to the challenges arising from the COVID-19 outbreak situation, the LegCo Finance Committee approved the funding proposal of \$137.5 billion in relation to the second round of the Anti-epidemic Fund ("the Fund") on 18 April 2020, so as to implement measures to comprehensively help businesses stay afloat, keep employees in employment, relieve financial burdens on businesses and individuals, and enable the economy to recover as soon as possible once the epidemic has subsided. The cost of implementing the whole package of measures is \$137.5 billion. Together with the \$30 billion under the first round of the Fund and the relief measures under the Budget which involves \$120

billion, the total fiscal implication for the Government is \$287.5 billion, representing about 10% of Hong Kong's Gross Domestic Product. The Food and Health Bureau ("FHB") is following up on the implementation of waiving the registration and enrolment fees for some 125 000 healthcare professionals for three years starting from July 2020.

(h) Health and Medical Research Fund

48. The Research Council chaired by SFH approved total funding of \$111 million under the Health and Medical Research Fund on 27 April 2020 to support the two medical schools of the University of Hong Kong and Chinese University of Hong Kong to conduct 26 medical research studies on COVID-19.

49. The research studies include development of vaccines and novel antiviral drug candidates; sero-epidemiological studies of COVID-19 in the community; investigation of the properties, characteristics, spread, infection and effective therapeutic interventions of SARS-CoV-2 (the virus that causes COVID-19); and investigation on Hong Kong's system of early detection, assessment and response to the COVID-19 outbreak.

50. As much is still unknown about the spread and diagnostics of COVID-19, the FHB will continue to invite new research proposals to address important research questions from other universities in addition to the two medical schools.

(i) Liaison with Mainland health authorities and international cooperation

51. The Government has been maintaining close liaison and cooperation with the Mainland health authorities as well as international organisations. For example, SFH and the Under Secretary for Food and Health respectively attended meetings hosted by the WHO Regional Director for the Western Pacific on 28 February and 8 April 2020, and shared key measures of Hong Kong and reaffirmed the importance of international cooperation, in particular transparency and timely information exchange, in fighting COVID-19 together.

52. In addition, on 8 February 2020, representatives of the FHB and DH attended a special meeting on COVID-19 by the Asia-Pacific Economic Cooperation ("APEC") Health Working Group. Amongst others, APEC Member Economies recognised the importance of sharing information and explored potential ways to strengthen international cooperation.

53. FHB and DH will continue to work closely with the WHO, in particular on the focal issues of the other Member States of the International Health Regulations (2005), and with the APEC Health Working Group and health authorities of other jurisdictions in coping with and putting the epidemic situation under control together, in order to safeguard the health of Hong Kong people and maintain Hong Kong's robust healthcare system.

(j) Risk communication and transparency

54. Risk communication is key to managing the public anxieties during this critical period. Apart from briefings (normally at 4:30 p.m. daily) by CHP and HA senior representatives on the number of cases (suspected, confirmed or under investigation), relevant contact tracing, quarantine arrangement, etc., the latest situation of COVID-19 in Hong Kong and the most updated health advice could be found at the "COVID-19 Thematic Website" (www.coronavirus.gov.hk/eng/index.html). The Government also launched Interactive Dashboard Map an (chp-dashboard.geodata.gov.hk/covid-19/en.html) and a Telegram channel named "Hong Kong Anti-epidemic Information Channel" (t.me/HKFIGHTCOVID19) to provide the latest information in a timely Senior officials also announce from time to time major manner. government decisions and measures, as well as to update the public on major developments in combating the virus, through press conferences or other occasions.

55. CHP has issued guidelines reminding citizens to be aware of personal and environmental hygiene, and disseminated relevant health messages to citizens on preventing communicable diseases and maintaining social distancing, etc. through various channels including

Announcements in the Public Interest on both television and radio, Facebook page, Instagram platform, YouTube channel, newspapers, the "GovHK Notifications" mobile app, health education infoline, media interviews, public transport, outdoor and digital media, etc. CHP has also produced various health education materials, including leaflets, posters, infographics and pamphlets, etc. for dissemination at the community level to enhance promotion. It also maintains close liaison with different stakeholders and keeps them informed of the latest situation and preventive measures. At the same time, CHP has produced latest updates and health advice in nine ethnic minority languages⁶. Furthermore, seven television commercials had been produced for airing as at 19 April 2020. In addition, FEHD has disseminated relevant information, including arrangements regarding the catering business as well as food safety messages, through the Centre for Food Safety and the social media pages of Keep Clean Ambassador Ah Tak.

Schedule 1 to the Prevention and Control of Disease (Prohibition on Group Gathering) Regulation ("the Regulation") (Cap. 599G) lists out the following 13 exempted group gatherings:

- 1. Group gathering for the purposes of or related to transportation
- 2. Group gathering for performing any governmental function
- 3. Group gathering for performing any function of a statutory body or an advisory body of the Government
- 4. Group gathering at a place of work for the purposes of work
- 5. Group gathering for obtaining or receiving hospital or healthcare service at a healthcare facility
- 6. Group gathering of persons living in the same household
- 7. Group gathering for—

(a) the conduct of proceedings in a court, magistrates' court or tribunal;

(b) the performance of any function of a judge or judicial officer; or

- (c) the conduct of any other business of the Judiciary
- 8. Group gathering necessary for the proceedings in the Legislative Council or a District Council
- 9. Group gathering during a funeral, or during any other occasion for mourning for or remembering a deceased who has yet to be buried or cremated (including any ritual or ceremony held in the vicinity of the place where the deceased died or suffered fatal injury to mourn for the death of the deceased)
- 10.Group gathering of not more than 50 persons during a wedding ceremony at which no food or drink is served
- 11.Group gathering during any of the following meetings at which no food or drink is served and, in the case of a group gathering of more than 50 persons, measures are in place for separating them in different rooms or partitioned areas, each accommodating not more than 50 persons—

(a) a meeting of a body that must be held within a specified period in order to comply with any Ordinance or other regulatory instrument that governs the operation of the body or its business;

(b) a shareholders' meeting of a company listed on a recognised stock market (as defined by section 1 of Part 1 of Schedule 1 to the

Securities and Futures Ordinance (Cap. 571)) that is held in accordance with any Ordinance or other regulatory instrument that governs the operation of the company or its business

- 12.Group gathering held for imparting information or skills, or handling supplies or items, that are conducive to the prevention and control of the specified disease
- 13.Group gathering at any premises to which a direction issued under section 8 of the Prevention and Control of Disease (Requirements and Directions) (Business and Premises) Regulation (Cap. 599F) applies, except premises that, according to the direction, must be closed

In addition to the 13 exemptions listed under Schedule 1, the Regulation also empowers the Chief Secretary for Administration to permit any group gathering if the Chief Secretary for Administration is satisfied that the taking place of the gathering -

(a) is necessary for governmental operation; or

(b) because of the exceptional circumstances of the case, otherwise serves the public interest of Hong Kong.
