### 2020 MTR fare adjustment

#### Supplementary information on 2020 MTR fare adjustment

#### Expenditure and revenue for Hong Kong transport operations

Regarding the expenditure and revenue for Hong Kong transport operations of the MTRCL in 2019, the expenditure on train operations (including depreciation, amortisation and variable annual payment) rose substantially by 17.3% to about \$20.5 billion. In the same year, the total revenue for Hong Kong transport operations slightly increased by 2.3% to about \$19.9 billion (see the breakdown below), which could not offset the increase in expenditure.

### Financial impact of public order events ("POEs") on the MTRCL

The continuous large-scale POEs taking place since the latter half of last year have had an unprecedented impact on the services of MTR. Since August last year, with violent confrontations escalating, the MTR network, including various railway lines and multiple station facilities were heavily vandalised, causing significant damage to MTR property and posing serious threat to the safety of MTR passengers, staff and the railways. According to the estimation as at December 2019, the POEs taken place in the latter half of 2019 had an adverse impact of \$2.3 billion on the performance of the MTRCL (including the expenditure of about \$600 million for reinstating vandalised facilities<sup>1</sup>, other impacts on the revenues for transport operations, station business and property leasing business, and the expenditure for employing additional manpower during the said period, etc.).
