WKCDA responded that: (a) the Authority had been working on the cultural software development of HKPM, such as exhibition planning, audience building, promotional and educational programming, in preparation of its commissioning in 2022; (b) meanwhile, LCSD had been collaborating with the Palace Museum on various educational activities and exhibitions on the collections of the Palace Museum at LCSD's museums since 2012, such as an exhibition currently held at the Hong Kong Science Museum and another one to be held at the Hong Kong Heritage Museum in 2021, with a view

		to enhancing public understanding of the Palace Museum and building an audience base; and (c) HKPM would organize various pre-opening programmes in 2021, including a large-scale exhibition. WKCDA would also study suitable directions for co-operation among HKPM, LCSD and the Palace Museum to showcase the rich collections of the Palace Museum in future. The Administration indicated that: (a) the permanent HKPM, once completed, would become the main venue for exhibiting the collections of the Palace Museum; (b) being the policy bureau in charge of cultural affairs, the Home Affairs Bureau ("HAB") had been facilitating the collaboration between LCSD and WKCDA. LCSD had been collaborating with WKCDA on various occasions, such as programmes for the Asia Cultural Co-operation Forum, an event held by HAB in December 2019 participated also by the Director of the Palace Museum. In 2019, the newly appointed Director of Leisure and Cultural Services ("DLCS") and the Museum Director of HKPM together paid a courtesy visit to Beijing and met the Director of the Palace Museum; and (c) the Board of HKPM Limited included members who were familiar with the work of LCSD, including DLCS as well as a member of the Museum Advisory Committee under LCSD.

		(a) Studio 1 of the Xiqu Centre was normally used for rehearsal. It had been converted for about two months every year to stage experimental performances during the <i>Experimental Chinese Opera Series</i> for the purposes of promoting creative works and building audience. In 2020, the <i>Experimental Chinese Opera Series</i> would be held between mid-September and December;	
		(b) both Farewell My Concubine (New Adaptation) and Wenguang Explores the Valley were produced by the Xiqu Centre. The playwrights owned the copyright of the play scripts, and the Xiqu Centre owned the copyright on performance;	
		(c) based on the famous <i>Generals of the Yang Family</i> , <i>Wenguang Explores the Valley</i> had its world premiere in Beijing in November 2019 and would be staged at the Xiqu Centre in October 2020; and	
		(d) <i>Bamboo Theatre</i> was a documentary fully funded by the Xiqu Centre to showcase a unique form of architecture preserved in Hong Kong, namely temporary bamboo structure erected for staging Cantonese opera performances.

		(a) a centralized customer relationship management system had been in use to enable the Authority to

The technology to be adopted should assist the Authority in monitoring the general movement of visitors in a museum as well as encouraging visitors to interact with the exhibits there and personalize their journey without collecting their personal data excessively.

		(b) the effectiveness of the monitoring system put in place by WKCDA, in view of the repeated failure of M+ contractor/sub-contractor to make timely wage payments; and	
		(c) whether WKCDA had set key performance indicators ("KPIs")/specific targets (e.g. number of docents and interns to be recruited and number of training programmes to be organized for nurturing the local talent) to evaluate the effectiveness of the cultural software development programmes, and whether the implementation of these programmes could dovetail with the progress of the hardware development in WKCD.	
		WKCDA advised that:	
		(a) it was the responsibility of LTBS to pay wages to employees. When it became evident that LTBS failed to pay its employees on time, the Authority

		took action to terminate M+'s small sub-contract with LTBS, and had followed up the wage claims with the Labour Department. As at 25 December 2019, about 120 workers of LTBS had been paid while two cases were yet to be settled due to inability of the workers concerned to provide sufficient evidence to prove their attendance; (b) the Authority had drawn up a set of KPIs for each division and was considering the inclusion of KPI results in the Annual Report of WKCDA; and (c) the Authority had offered a variety of paid internships and docent volunteer programmes as well as talks/lectures/symposia for audience and capacity building. For instance, 10 museum interns were recruited every year under the M+ Internship Programme and some of them had joined WKCDA as full-time employees afterwards; 12 interns were recruited under the Venice Biennale Internship Programme in collaboration with the Hong Kong Arts Development Council; and WKCDA targeted to have about 200 volunteers in place to provide docent service in preparation for the opening of M+ after training. Besides, at least three M+ Matters series of public talks hosted by universities and keynote speakers were organized every year.

WKCDA advised that: (a) the Authority had launched individual membership scheme for each facility like M+. WKCDA was working on a similar one for performing arts and in due course for HKPM in future in order to collect members' views on its programmes and reward members. As far as the M+ building was concerned, the statutory inspection on the building was expected to be carried out in January 2020. 		(c) on the commercial developments, as the ACE project was not contingent on the M+ project and not constructed on top of the integrated basement ("IB") which was yet to be completed, the Authority could take forward the project early. Subject to the approval of the WKCDA Board, the tendering process of the ACE project could be commenced in January 2020. The Authority also planned to commence commercial development projects at Parcels P31 and P34 in mid-2020.	
		The Administration advised that:	
		(a) the endowment fund approved by the Legislative Council in 2008 and the apportioned investment income would only be sufficient to build the Batch 1 and most of Batch 2 facilities. The Government would undertake the communal and government facilities and related engineering works (collectively known as "public infrastructure works"), while WKCDA was responsible for the operating costs of WKCD;	
		(b) according to the enhanced financial arrangement ("EFA") for WKCD, WKCDA was granted the development right of the hotel/office/residential portion of WKCD for development under the Build-Operate-Transfer model to sustain its operation. It had been projected in EFA that WKCDA would need to explore the need to raise funds (e.g. through external borrowing) by around 2022/2023; and	
		(c) as the topside commercial developments in WKCD was dependent on the construction of IB, no income could be generated therefrom so far. As such, Members were appealed to expeditiously approve the funding proposal of the remaining works of IB.

		(b) it had conducted survey to collect the feedback of hirers on the use of WKCD venues, which was in general positive. That said, the Authority would study how to improve the operation of these newly opened venues based on the feedback received. Taking the Xiqu Centre as an example, the Authority had held a meeting with the Chinese Artists Association of Hong Kong to review in detail the use of the centre;	
		(c) in view of the financial situation of WKCDA, the proposal of renting out the venues in the Xiqu Centre free of charge would not be pursued. Rather, the Authority would consider bearing part of the operating costs of the venues together with partner organizations;	
		(d) while the Xiqu Centre was dedicated to xiqu performances in 2019 (the first year of operation), flexibility was allowed in using the Xiqu Centre for other purposes from 2020 onwards;

		The Chairman shared his parking experience at WKCD and said that plenty of parking spaces were available there. Yet, he considered that more pick-up/drop-off points could be provided in WKCD to enhance its accessibility.

		(b) as the completion of the proposed ASB would greatly enhance the accessibility of WKCD from the MTR Kowloon Station, Members were earnestly requested to expeditiously approve the relevant funding proposal;	
		(c) with the support of the Government, the Authority had been studying the provision of marine access in WKCD;	
		(d) the illegal parking issue in WKCD was more on the unwillingness of drivers to pay for parking than a shortage of parking spaces, as there were about 260 private car parking spaces (including those for the disabled and electric vehicles) around the Art Park and at the project site office. Relevant feasibility study was underway and government officials had met with Dr WONG to discuss the matter;
