I. Election of Chairman and Deputy Chairman for the 2019-2020 session

Election of Chairman

Mr KWONG Chun-yu, the incumbent Chairman, called for nominations for the chairmanship of the Panel for the 2019-2020 session. Mr KWONG Chun-yu was nominated by Mr CHAN Chi-chuen and the nomination was seconded by Dr KWOK Ka-ki. Mr KWONG accepted the nomination. As Mr KWONG was nominated for the chairmanship, the election was presided over by Mr SHIU Ka-chun, the incumbent Deputy Chairman.

2. As there was no other nomination, Mr SHIU Ka-chun declared Mr KWONG Chun-yu elected as Chairman of the Panel for the 2019-2020 session. Mr KWONG then took the chair.

Election of Deputy Chairman

3. <u>The Chairman</u> called for nominations for the deputy chairmanship of the Panel for the 2019-2020 session. Mr SHIU Ka-chun was nominated by <u>Dr KWOK Ka-ki</u> and the nomination was seconded by

Mr CHU Hoi-dick. Mr SHIU accepted the nomination.

4. As there was no other nomination, <u>the Chairman</u> declared Mr SHIU Ka-chun elected as Deputy Chairman of the Panel for the 2019-2020 session.

5. <u>Members</u> agreed that regular meetings of the Panel would be held on the second Monday of each month at 10:45 am. As 13 April 2020 was a public holiday, <u>members</u> agreed that the regular meeting in April be rescheduled to 20 April 2020 at 10:45 am.
