Shipping and Port Control Ordinance (Chapter 313) Merchant Shipping (Local Vessels) Ordinance (Chapter 548)

Enhancements to Speed Restricted Zones Within Hong Kong Waters

INTRODUCTION

At the meeting of the Executive Council on 8 October 2019, the Council ADVISED and the Chief Executive ORDERED that the Shipping and Port Control (Amendment) (No. 2) Regulation 2019 ("the SAPCR Amendment Regulation"), at **Annex A**, should be made under section 80 of the Shipping and Port Control Ordinance (Cap. 313) to implement enhancement measures in relation to Speed Restricted Zones within Hong Kong waters with a view to enhancing marine safety.

2. The Secretary for Transport and Housing has, under section 89 of the Merchant Shipping (Local Vessels) Ordinance (Cap. 548), made the Merchant Shipping (Local Vessels) (General) (Amendment) (No. 2) Regulation 2019 ("the Local Vessels Amendment Regulation"), at **Annex B**, to apply the same enhancement measures to local vessels.

JUSTIFICATIONS

SRZs

3. To protect members of the public engaged in water sports as well as facilities in Fish Culture Zones ("FCZs"), 22 SRZs have been set up in Hong Kong waters to restrict the speed of vessels plying therein. Boundaries of these SRZs are set out in the Eighteenth Schedule to the Shipping and Port Control Regulations (Cap. 313A) ("SAPCR"). The SAPCR, together with the Merchant Shipping (Local Vessels) (General) Regulation (Cap. 548F) ("the Local Vessels Regulation"), mandate that all vessels must not proceed at speeds exceeding five knots while plying within

 $SRZs^1$. At present, such restriction is in force between the hours of 8 a.m. and 12 midnight on any Saturday or public holiday, or between the same time on any day during the period from 1 July to 15 September inclusive in any year ("the restriction period").

Legislative Proposal

4. We propose to amend the SAPCR and the Local Vessels Regulation to implement the following enhancement measures in relation to SRZs.

(A) Establishment of eight additional SRZs

5. In view of the increasing frequency of water sports activities, as well as the FCZs in their proximity, we propose to establish four additional SRZs in Tai Po District and another four in Sai Kung District. Their locations are shown at **Annex C**. The restriction period of these additional SRZs will be in line with that of the existing SRZs (save for the 13 existing SRZs whose restriction period is proposed to be extended as detailed in paragraph 6 below).

(B) Extension of the restriction period of selected existing SRZs

6. We propose to extend the restriction period of 13 existing SRZs, as follows —

- (a) the restriction periods of 12 SRZs located in Hong Kong Island South, Lamma Island, Cheung Chau and Lantau Island are proposed to be extended to cover the period from 1 April to 31 October inclusive in any year, having regard to the changing pattern of water sports activities in those areas, such as extended peak swimming seasons at public beaches; and
- (b) the restriction period of the Hebe Haven SRZ is proposed to be extended to all year round, having regard to the heavy marine traffic and frequent water sports activities in the area throughout the year.

¹ The existing SRZ regime is made applicable to local vessels vide the Local Vessels Regulation, which stipulates that local vessels shall not, when underway in SRZs specified in the Eighteenth Schedule to the SAPCR, proceed at speeds exceeding five knots during the restriction period.

(C) Extension of the boundary of the East Kiu Tsui Chau SRZ

7. To provide better protection to the facilities within the Kai Lung Wan FCZ, we propose to extend the existing boundary of the East Kiu Tsui Chau SRZ. The proposed extended boundary is shown at **Annex D**.

(D) Increase in penalty levels

D

8. To reflect the increased risks associated with breaching SRZ regulations, we propose to increase the penalty level of breaching such regulations from a maximum fine at level 1 (\$2,000) to a maximum fine at level 3 (\$10,000).

(E) Update of coordinates from Hayford Geodetic Datum to World Geodetic System 1984

9. At present, the coordinates specifying the location of certain SRZs in the SAPCR are set out in Hayford Geodetic Datum, a coordinates system which has been superseded by the World Geodetic System 1984 (WGS84). In line with the latest international practice, we propose to update the coordinates of the existing 22 SRZs set out in the SAPCR such that they are expressed in WGS84 coordinates.

THE REGULATIONS

Shipping and Port Control (Amendment) (No. 2) Regulation 2019

10. To implement the proposed enhancement measures, we will amend Regulation 19 of the SAPCR by way of the SAPCR Amendment Regulation. In particular, subsection (3) will be amended to extend the restriction period of Hebe Haven SRZ to all year round, and to extend the restriction periods of 12 SRZs located in Hong Kong Island South, Lamma Island, Cheung Chau and Lantau Island to cover the period from 1 April to 31 October inclusive in any year. We will also amend subsection (5)(b) to increase the penalty level of breaching relevant SRZ regulations to a fine at level 3.

11. The Eighteenth Schedule to the SAPCR will be amended to become Schedule 18 to the SAPCR. We will add items 1(c), 1(d), 1(e), 1(f), 2(i), 2(j), 2(k) and 2(l) thereto to incorporate the coordinates of the

eight additional SRZs in the Tai Po and Sai Kung Districts. We will also amend item 2(d) to incorporate the coordinates of the extended boundary of the East Kiu Tsui Chau SRZ. The coordinates of all SRZs set out in Schedule 18 to the SAPCR will be amended such that they are expressed in WGS84 coordinates.

Merchant Shipping (Local Vessels) (General) (Amendment) (No. 2) Regulation 2019

12. To apply the proposed enhancement measures to local vessels, we will relatedly amend section 9 of the Local Vessels Regulation by way of the Local Vessels Amendment Regulation. In particular, subsection (3) will be amended to extend the restriction period of Hebe Haven SRZ to all year round, and to extend the restriction periods of 12 SRZs located in Hong Kong Island South, Lamma Island, Cheung Chau and Lantau Island to cover the period from 1 April to 31 October inclusive in any year. We will also amend subsection (6) to increase the penalty level of breaching relevant SRZ regulations to a fine at level 3.

IMPLICATIONS OF THE PROPOSAL

14. The proposal is in conformity with the Basic Law, including the provisions concerning human rights. It will not affect the current binding effect of the relevant ordinances or their subsidiary legislation. The proposal has no financial, civil service, economic, productivity, environmental, sustainability, gender or family implications.

PUBLIC CONSULTATION

15. We consulted the Legislative Council Panel on Economic Development on 19 December 2018. Members supported the proposal.

16. The Local Vessel Advisory Committee, the Traffic and Transport Committee of the Tai Po District Council, Sai Kung Area Committee, relevant trade and fishery associations of the Southern and the Island districts were also consulted between 2015 to 2018 and they supported the proposal.

17. A press release will be issued on 18 October 2019. A spokesperson will be available to handle press enquiries.

- (b) increasing the penalties for contravening the relevant regulations;
- (c) establishing 8 additional RZs;
- (d) extending the boundaries of the East Kiu Tsui Chau RZ;
- (e) updating the co-ordinates specifying the location of certain RZs from those based on the Hayford Geodetic Datum to those based on the World Geodetic System 1984 (WGS 84).



Explanatory Note

This Regulation amends the Merchant Shipping (Local Vessels) (General) Regulation (Cap. 548 sub. leg. F) to implement the following enhancement measures relating to restricted zones within the waters of Hong Kong—

- (a) extending the period during which the speed of local vessels plying within 13 existing restricted zones is restricted;
- (b) increasing the penalties for contravening the relevant regulations.
