LEGISLATIVE COUNCIL BRIEF

PUBLIC HEALTH AND MUNICIPAL SERVICES ORDINANCE CHANGES TO PLACES SET ASIDE FOR USE AS PUBLIC PLEASURE GROUNDS

INTRODUCTION

The Director of Leisure and Cultural Services, in his capacity as the Authority ("Authority") under Section 106(1) and (6) of the Public Health and Municipal Services Ordinance, Cap.132 ("the Ordinance"), may, from time to time, by order set aside places for use as public pleasure grounds, and may by order amend the Fourth Schedule to the Ordinance.

2. We propose to introduce amendments through the Public Health and Municipal Services Ordinance (Public Pleasure Grounds) (Amendment of Fourth Schedule) Order 2020 ("the Amendment Order") to set aside the fourteen places specified in Schedule 1 to the Amendment Order for use as public pleasure grounds and to rename two public pleasure grounds. The Amendment Order is at Annex to this Brief.

JUSTIFICATIONS

3. The proposal to set aside fourteen venues as public pleasure grounds will enable the Authority to enforce the Pleasure Grounds Regulation (Cap 132, subsidiary legislation BC) in those venues. We also propose to rename two public pleasure grounds.

PLACE TO BE SET ASIDE FOR USE AS PUBLIC PLEASURE GROUNDS

- 4. The following fourteen venues will be designated as public pleasure grounds and be included in the Fourth Schedule to the Ordinance-
 - (i) Two venues that are developed by Architectural Services Department for public use and handover to the Leisure and Cultural Services Department (LCSD) for management:
 - (a) Central and Western District Promenade—Western Wholesale

Food Market Section

- (b) Kai Tak Promenade (Hong Kong Children's Hospital Section)
- (ii) Three venues that are taken over from the Home Affairs Department for management by LCSD:
 - (a) Pok Fu Lam No.3 Service Reservoir Sitting-out Area
 - (b) Sassoon Road Sitting-out Area
 - (c) Tai Po Tau Road Sitting-out Area
- (iii) One venue that is taken over from Development Bureau:
 - (a) Battery Path Sitting-out Area
- (iv) Four venues that are taken over from Civil Engineering and Development Department:
 - (a) Kai Tak Sky Garden
 - (b) Tuen Mun Cycling Entry/ Exit Hub
 - (c) Tin Shui Wai Cycling Entry/ Exit Hub
 - (d) Yuen Long Town Cycling Entry/ Exit Hub
- (v) Four venues that are taken over from Housing Department:
 - (a) On Sau Road Park
 - (b) Sham Mong Road Playground
 - (c) Sham Shui Po Sports Centre
 - (d) Shek Mun Riverside Garden

RENAMING OF PUBLIC PLEASURE GROUNDS

5. Lok Shan Road Playground is recommended to be renamed as Lok Shan Road Sitting-out Area in order to tie in with the reduction in size from 600 m² to 351m² with the provision of passive amenity only after the construction of Shatin-Central Link. Hence the nomenclature has been changed from "playground" to "sitting-out area".

6. Silver Mine Bay Viewing Deck (銀礦灣觀景台) is recommended to be renamed as Silver Mine Bay Viewing Deck (銀礦灣觀景台) by making reference to the names of roads, village, geographical place and significant landmark in vicinity.

AMENDMENT OF FOURTH SCHEDULE

7. The Amendment Order at Annex amends the Fourth Schedule to the Public Health and Municipal Services Ordinance (Cap. 132) to give effect to the changes set out in paragraphs 4, 5 and 6 above.
