REGISTRATION OF PERSONS (APPLICATION FOR NEW IDENTITY CARDS) ORDER 2018 (AMENDMENT) ORDER 2020

INTRODUCTION

In the light of the epidemic of coronavirus disease 2019 (COVID-19), the Immigration Department ("ImmD") earlier suspended the replacement service for Hong Kong identity cards ("HKICs") under the Territory-wide Identity Card Replacement Exercise ("Replacement Exercise"). To ensure the resumption of the Replacement Exercise in an orderly manner, the Secretary for Security ("the Secretary") made the Registration of Persons (Application for New Identity Cards) Order 2018 (Amendment) Order 2020 ("the Amendment Order") (at **Annex**), pursuant to section 7B(1) of the Registration of Persons Ordinance (Cap. 177) ("the Ordinance") to –

- (a) extend the specified periods for holders of target HKICs¹ born in 1957 to 1961 to apply for new HKICs;
- (b) amend the specified periods for holders of target HKICs born in 1962 to 1963 and those in 1970 to 1976 to apply for new HKICs;
- (c) extend the specified period in which eligible members of the sixth-term District Council ("DCs")² may apply for new HKICs; and

Target HKICs are valid HKICs prepared under regulation 5(1)(a) of the Registration of Persons Regulations (Cap 177A) and issued before 26 November 2018 (or issued on or after that date as a result of an application made before that date).

The arrangement will not be applicable for the following DC members whose –

⁽a) HKICs show a year of birth of 1955, 1956, 1964, 1965, 1966, 1967, 1968, 1969, 1985 or 1986. These members have been called up for HKIC replacement in the first or second cycle of the Replacement Exercise; and

⁽b) HKICs show a year of birth of 1957 to 1961. The specified periods of the respective age groups of these members will be extended to 27 July 2020 or under the circumstance of paragraph 6 below to 22 September 2020 (i.e. same as the amended specified period for DC members).

(d) further extend or amend the specified periods for persons concerned in sub-paragraphs (a) to (c) above to apply new HKICs, if all Replacement Centres are not in service for a period of 21 working days³ or more between 11 May 2020 and 27 July 2020 for public health reasons.

BACKGROUND

2. In November 2019, the Secretary for Security made the Registration of Persons (Application for New Identity Cards) (Amendment) (No.2) Order 2019 ("ROP Order 2019 (No. 2)"), pursuant to section 7B(1) of the Ordinnace, to specify the arrangement of the third cycle of the Replacement Exercise. The ROP Order 2019 (No.2) directs holders of target HKICs born in 1957 to 1963 to apply for new HKICs within the following specified periods –

- 3. Moreover, the ROP Order 2019 (No. 2) provides that eligible members of the sixth-term DC may apply for new HKICs from 18 February to 20 April 2020, in addition to replacing their HKICs in the periods specified for their age groups.
- 4. To reduce the risk of the spread of COVID-19 as a result of the gathering of applicants, ImmD had implemented special service arrangement since January 2020. The operation of all Replacement Centres was suspended from 29 January to 1 March 2020 and from 23 March to 3 May 2020⁴. Due to the service suspension, some 640 000

From 4 May 2020, ImmD has resumed the services of all Replacement Centres in phases. The Replacement Centres first provide HKIC collection service and registration of new HKICs service for those applicants born in 1957 to 1961 who had made appointments earlier.

holders of target HKICs born in 1957 to 1963 were unable to register for new HKICs during the periods specified for their age groups. Meanwhile, some eligible DC members were unable to apply for new HKICs during the specified period for DC members.

REVISED ARRANGEMENT FOR REPLACEMENT EXERCISE

- 5. As the epidemic has signs of stabilising, the operation of all Replacement Centres will be fully resumed from 11 May 2020. Having regard to the substantial number of persons who have not yet applied for new HKICs due to the earlier service suspension, we need to change the arrangement for the third cycle of the Replacement Exercise. The objective is to avoid substantial number of applicants registering new HKICs at Replacement Centres in the early stage of service resumption, with a view to ensuring that the Replacement Exercise will continue to be conducted in an orderly manner. To this end, the Secretary made the Amendment Order pursuant to the Ordinance to -
 - (a) extend the specified periods for holders of target HKICs born in 1957 to 1961 to apply for new HKICs to 27 July 2020;
 - (b) amend the specified periods for holder of target HKICs born in 1962 to 1963 and those in 1970 to 1976 to apply for new HKICs as follows –

(c) extend the specified period in which eligible members of the six-term DC may apply for new HKICs to 27 July 2020.

- 6. While the situation of the epidemic has stablised, we do not rule out the possibility that the replacement service for HKICs may need to be suspended again in near future to cope with sudden turn of the epidemic situation. Hence, the Amendment Order also provides that if all Replacement Centres are not in service for a period of 21 working days or more from 11 May to 27 July 2020 for public health reasons, the arrangement of Replacement Exercise will be further adjusted as follows
 - (a) the specified periods for holders of target HKICs born in 1957 to 1961 to apply for new HKICs will be further extended to 22 September 2020;
 - (b) the specified periods for holders of target HKICs born in 1962 to 1963 and those in 1970 to 1976 to apply for new HKICs will be amended as follows –

- (c) the specified period in which eligible DC members may apply for new HKICs will be further extended to 22 September 2020.
- 7. If the arrangement of the Replacement Exercise has to be adjusted under the circumstance mentioned in paragraph 6, ImmD will make announcement in advance as far as possible through various channels to inform the public of the new arrangement.

THE AMENDMENT ORDER

8. 1 of the Amendment Order provides for Section commencement date. **Section 3** amends Section 2 of the Registration of Persons (Application for New Identity Cards) Order 2018 (Cap. 177J) ("the ROP Order 2018") by adding the definitions of "specified period" and "substituted period". **Section 4** amends section 4 of the ROP Order 2018 by adding substituted period in addition to specified period. amends section 5(3) of the ROP Order 2018 by amending the specified period for DC members and adding the substituted period under the adjustment arrangement mentioned in paragraph 6(c) above. amends section 6(1)(a)(i) of the ROP Order 2018 by adding substituted period in addition to specified period. **Section 7** amends section 7(1)(b) and (2)(b) of the ROP Order 2018 by adding substituted period in addition **Section 8** provides for the adjustment arrangement to specified period. mentioned in paragraph 6 above. Section 9 amends Schedule 2 of the ROP Order 2018 by amending the specified periods of 1957 to 1963 and 1970 to 1976 and adding substituted period for these years of birth as mentioned in paragraphs 5 to 6 above.

IMPLICATIONS OF THE PROPOSAL

10. The Amendment Order is in conformity with the Basic Law, including the provisions concerning human rights and does not affect the current binding effect of the Ordinance and the Registration of Persons Regulations (Cap. 177A).

PUBLIC CONSULTATION

11. On 5 December 2017, the Panel on Security was briefed on the new form of HKIC and the framework of the Replacement Exercise. Members raised no objection to the framework of the Replacement Exercise. The public and LegCo members have been informed of the arrangement of the Replacement Exercise as set out in the Legislative Council Briefs on the ROP Order 2018 tabled at the LegCo on 24 October 2018, the Registration of Persons (Application for New Identity Cards) (Amendment) Order 2019 tabled at the LegCo on 3 April 2019 and ROP Order 2019 (No. 2) tabled at LegCo on 27 November 2019.

PUBLICITY

12. ImmD will issue a press release on the abovementioned arrangement of the Replacement Exercise. If the arrangement of the Replacement Exercise has to be adjusted for public health reasons as mentioned in paragraph 6 above, ImmD will inform the public through various channels in advance as far as possible.

Explanatory Note

The replacement of Hong Kong identity cards under the Territory-wide Identity Card Replacement Exercise has been interrupted due to the suspension of service of smart identity card replacement centres to contain the coronavirus disease 2019 (COVID-19). This Order amends the following provisions of the Registration of Persons (Application for New Identity Cards) Order 2018 (Cap. 177 sub. leg. J) (*principal Order*) to provide for new application periods in relation to the relevant groups of people, and for substituted application periods if a certain circumstance arises—

- (a) section 4 and Schedule 2—in relation to holders of target identity cards that show 1957, 1958, 1959, 1960, 1961, 1962, 1963, 1970, 1971, 1972, 1973, 1974, 1975 or 1976 as the year of birth;
- (b) section 5—in relation to certain members of District Councils;
- (c) section 6—in relation to elderly persons or qualified persons with a disability, who apply for the new identity cards concurrently with their accompanying persons; and
- (d) section 7—in relation to residents of residential care homes.
- 2. The Order adds a new section 8 to the principal Order to provide for the circumstance under which the substituted application periods may apply, namely, none of the replacement centres is in service for public health reasons for 21 working days or more during the period from 11 May 2020 to 27 July 2020.
