WAIVER OF REGISTRATION AND RELATED FEES FOR HEALTHCARE PROFESSIONALS

INTRODUCTION

At the meeting of the Executive Council on 26 May 2020, the Council ADVISED and the Chief Executive ORDERED that the following regulations and order should be made -

- (a) the Dentists (Fee Concessions) Regulation 2020, at <u>Annex A</u>;
- (b) the Dental Hygienists (Fee Concessions) Regulation 2020, at <u>Annex B;</u>
- (c) the Medical Practitioners (Fee Concessions) Regulation 2020, at <u>Annex C;</u>
- (d) the Midwives (Fee Concessions) Regulation 2020, at <u>Annex</u> <u>D</u>;
- (e) the Registered Nurses (Fee Concessions) Regulation 2020, at <u>Annex E</u>;
- (f) the Enrolled Nurses (Fee Concessions) Regulation 2020, at <u>Annex F;</u>
- (g) the Medical Laboratory Technologists (Fee Concessions) Regulation 2020, at <u>Annex G</u>;
- (h) the Occupational Therapists (Fee Concessions) Regulation 2020, at <u>Annex H;</u>
- (i) the Optometrists (Fee Concessions) Regulation 2020, at <u>Annex I;</u>
- (j) the Radiographers (Fee Concessions) Regulation 2020, at <u>Annex J;</u>

JUSTIFICATION

2. The Government has proposed to waive the registration/enrolment fees for some 125 000 healthcare professionals ("the waiver") for three years starting from 1 July 2020 ("the concession period"). Subsidiary legislation is required to effect the waiver. We propose to waive during the concession period the fees payable in respect of statutory registrations/enrolments for the 13 healthcare professions, as well as the fees payable in respect of the issuance or renewal of practising certificates that take effect during the concession period, subject to the restrictions set out below.

3. As registration in a healthcare profession generally only occurs once for a practitioner, the waiver for registration fees will be valid for one registration during the concession period. However, for a person whose name has been removed¹ or deleted¹ from the register, the waiver would not apply when the person applies during the concession period for his/her name to be re-entered into the register. Meanwhile, practising certificates require renewal, depending on the healthcare profession, either once every three years or annually. As such, the waiver will be applicable to the application for and/or renewal of practising certificates either once or three times at most during the concession period, subject to the statutory renewal interval of the respective healthcare profession.

THE REGULATIONS AND ORDER

4. The waiver will be valid for three years during the period from 1 July 2020 to 30 June 2023 (both dates inclusive).

Dentists

5. The Dentists (Fee Concessions) Regulation 2020, at Annex A, is made under the Dentists Registration Ordinance to waive the fees for registration, the inclusion of name in the Specialist Register, and the issuance of practising certificates.

Dental Hygienists

6. The Dental Hygienists (Fee Concessions) Regulation 2020, at Annex B, is made under the Dentists Registration Ordinance to waive the fees for enrolment.

Medical Practitioners

7. The Medical Practitioners (Fee Concessions) Regulation 2020, at Annex C, is made under the Medical Registration Ordinance to waive the fees for the registration in the General Register, the inclusion of name in the Specialist Register, and the issuance of practising certificates.

Midwives

8. The Midwives (Fee Concessions) Regulation 2020, at Annex D, is made under the Midwives Registration Ordinance to waive the fees for registration and the issuance of practising certificates.

Nurses

9. The Registered Nurses (Fee Concessions) Regulation 2020, at Annex E, is made under the Nurses Registration Ordinance to waive the fees for registration and the issuance of practising certificates.

10. The Enrolled Nurses (Fee Concessions) Regulation 2020, at Annex F, is made under the Nurses Registration Ordinance to waive the fees for enrolment and the issuance of practising certificates.

Medical Laboratory Technologists

11. The Medical Laboratory Technologists (Fee Concessions) Regulation 2020, at Annex G, is made under the Supplementary Medical Professions Ordinance to waive the fees for registration and the issuance of practising certificates.

Occupational Therapists

12. The Occupational Therapists (Fee Concessions) Regulation 2020, at Annex H, is made under the Supplementary Medical Professions Ordinance to waive the fees for registration and the issuance of practising certificates.

Optometrists

13. The Optometrists (Fee Concessions) Regulation 2020, at Annex I, is made under the Supplementary Medical Professions Ordinance to waive the fees for registration and the issuance of practising certificates.

Radiographers

14. The Radiographers (Fee Concessions) Regulation 2020, at Annex J, is made under the Supplementary Medical Professions Ordinance to waive the fees for registration and the issuance of practising certificates.

Physiotherapists

15. The Physiotherapists (Fee Concessions) Regulation 2020, at Annex K, is made under the Supplementary Medical Professions Ordinance to waive the fees for registration and the issuance of practising certificates.

Chiropractors

16. The Chiropractors (Fee Concessions) Regulation 2020, at Annex L, is made under the Chiropractors Registration Ordinance to waive the fees for registration, the issuance of certificates of registration and the issuance and renewal of practising certificates.

Chinese Medicine Practitioners

17. The Chinese Medicine Practitioners (Fee Concessions) Regulation 2020, at Annex M, is made under the Chinese Medicine Ordinance to waive the fees for registration and the issuance or renewal of practising certificates.

Pharmacists

18. The Revenue (Reduction of Fees for Pharmacists' Certificates of Registration and Practising Certificates) Order 2020, at Annex N, is made under the section 39A(a) of the Public Finance Ordinance to waive the fees for the issuance of certificates of registration and annual practising certificates.

LEGISLATIVE TIMETABLE

19. The waiver should be implemented as soon as possible so as to benefit the healthcare professionals as they continue their efforts in combating the pandemic. We therefore propose that the proposed subsidiary legislation to take effect on 1 July 2020. The Regulations and Order will be gazetted on 29 May 2020 and tabled in the Legislative Council on 3 June 2020 for negative vetting.

IMPLICATIONS OF THE PROPOSAL

20. The proposal is in conformity with the Basic Law, including the provisions concerning human rights. The proposal will not affect the binding effect of existing provisions of the relevant ordinances and their subsidiary legislation. It has no productivity, environmental, sustainability, economic, gender or family implications.

21. Civil service implications, if any, will be absorbed within the existing provision of the relevant bureau/department. The estimated revenue forgone to Government arising from the proposed fee waiver is about \$92 million.

PUBLIC CONSULTATION

22. The Government proposed the waiver as a token of appreciation to healthcare professionals in the fight against the coronavirus disease-2019. The waiver was announced by the Chief Executive in the context of the second round of relief measures in April 2020.
