Re: Item FCR(2019-20)27

I am writing to inquire about item FCR(2019-20)27 concerning studies related to artificial islands in the Central Waters. Given the fact that the proposed reclamation will be covering the Central Waters near Sunshine Island and Hei Ling Chau, where the globally-endangered and endemic Bogadek's burrowing lizard were recorded in previous studies, there are concerns that the proposed works will potentially affect this lizard and other wildlife on these two conservation important islands. Consequently, please kindly pass on the following questions to the government for their response before the item is discussed in the Finance Committee.
