

Numbers of traffic summons and fixed penalty tickets issued in the past three years in respect of illegal driving training activities and the relevant penalties

The Transport Department pays great attention to illegal driving training activities and has been working closely with the Police to regularly conduct joint enforcement operations to combat relevant illegal activities. From 2018 to now, the Police issued a total of 415 traffic summons and 33 fixed penalty tickets. The illegal activities involved and the relevant penalties are summarised below –

Illegal activity	Penalty
(a) Giving driving instruction without valid driving instructor's licence	Liable to, in the case of a first conviction, a fine of \$2,000 and imprisonment for three months;
(b) Driving learning at unspecified time period	and in the case of a second or subsequent conviction, a fine of
(c) Driving learning in prohibited area for learners	\$5,000 and imprisonment for six months ¹
(d) Driving learning without a learn plate ("L")	
(e) Learner's driving licence expired	Liable to, in the case of a first conviction, a fine of \$5,000 and imprisonment for three months; and in the case of a second or subsequent conviction, a fine of \$10,000 and imprisonment for six months ²
(f) Learner driver failed to carry driving licence when driving	Liable to, in the case of a first conviction, a fine of \$1,000; and in the case of a second or subsequent conviction, a fine of \$2,000 ²

過去三年有關違法駕駛訓練活動的交通傳票及 定額罰款通知書數字,以及相關罰則

運輸署一直非常關注違法駕駛訓練活動,並與警方緊密合作,定期舉行聯合行動打擊有關違法活動。由 2018 年至今,警方共發出 415 張交通傳票及 33 張定額罰款通知書,當中所涉及的違法事項及相關罰則載列於下表:
