# 改善市容事宜

委員會於 2 月 9 日舉行的視像會議中,討論有關改善市容事宜,討論集中於街道清潔、垃圾收集、以及店舗阻街等,本人認為涵蓋範圍過少,應該作比較全方面討論,才能真正有效「提升市容」,以下是本人認為應予以討論的事宜:

- 不少的「街道家具」(Street Furniture),如五花百門豎立在行人路的交通標誌、圍欄及 路牌等,多年來均令人感到欠缺設計及美感,無助改善市容;
- 不少損毀的行車路及行人路均未能及時維修,影響市容,亦易做成意外;
- 部分工程車輛及運送廢料的貨車等在馬路上行走時,因就運輸物品未有妥善處理,導致 沿途遺漏垃圾、泥士、碎石等問題,政府未有加強監管及執法不力,影響市容亦危害其 他道路使用者的安全;
- 規劃作休憩公園及休憩處等小面積地塊,未有妥善設計及利用,不少變成垃圾棄置區, 亦造成環境衞生欠佳。

本人理解要提升市容涉及不少部門權責,如路政署、運輸署及康文署等,故希望主席同意安排時間討論以上事項,並能邀請相關部門代表出席答覆議員的提問。謝謝!
