Bills Committee on Revenue (First Registration Tax and Licence Fees for Motor Vehicles) Bill 2021

Government's Response to Issues Raised at the meeting on 31 March 2021

The Government's response to the request for supplementary information raised at the Bills Committee meeting on 31 March 2021 is set out as follows.

Number of Government Cars

- 2. The Government procures various types of vehicles, including cars ¹, to support the operation of various bureaux, departments and offices. The uses of these cars include transportation of officers to carry out duties, to deliver documents, to carry out on-site inspection of facilities, etc.
- 3. As of end 2020, there were 1 577 cars in the Government fleet. For details on the number of cars of each bureau, department and office, please refer to **Annex**. The Chief Executive ("CE"), the three Secretaries of Departments, Directors of Bureaux and the Director of the CE's Office are individually provided with official cars which can be used for all purposes.

Growth of Licensed PCs

- 4. Unless otherwise specified in the Road Traffic Ordinance (Cap. 374)("RTO"), all vehicles must be registered as well as licensed before they can be driven or used on a road. Therefore, the number of licensed vehicles can better reflect the number of vehicles that can be driven on a road.
- 5. In the past ten years, the numbers and growth of licensed PCs are as follows –

Past Experience of Increasing the First Registration Tax ("FRT") and Vehicle Licence Fee ("VLF") for PCs

- 6. The FRT and VLF for PCs have not been adjusted since 2011 and 1991 respectively. The effect of adjustment experience is as follows –
- 7. In 1991, FRT was increased by about 16%, together with an increase of VLF by 10%. As mentioned above, the number of licensed vehicles can better reflect the number of vehicles that can be driven on a road, in order to reflect the overall impact of the relevant adjustment. Back then, 9 to 12 months after the increases, there was an overall drop in the average annual growth rate of licensed PCs from 9.4%² to 7.7%³.
- 8. In 2011, FRT was increased by about 15% without a parallel increase in VLF. 9 to 12 months after the FRT increase, the average annual growth rate for ordinary petrol licensed PCs was reduced from $3.6\%^4$ to $2.3\%^5$. However, on this occasion, the concession given to

environment-friendly petrol PCs was increased at the same time, which reduced the overall impact to suppress the growth rate of licensed PCs.

Illegal Carriage of Passengers by Motor Vehicles for Hire or Reward

9. Pursuant to Section 52 of RTO, no person shall drive or use a motor vehicle, or suffer or permit a motor vehicle to be driven or used, for the carriage of passengers for hire or reward unless the vehicle complies with certain conditions stipulated in RTO. For example, a hire car permit is in force in respect of the vehicle. Otherwise, it is an offence. The numbers of enforcement actions taken by the Police against illegal carriage of passengers by motor vehicles for hire or reward each year from 2018 to 2020 were around 50 to 180 times. The Police does not maintain information on the prosecution figures of illegal carriage of passengers by motor vehicles for hire or reward.
