She considered that instead of carrying functions outside Hong Kong, OPC should focus on improving its local business and financial health; and (b) OPC's plans to apply the Ocean Park Trust Fund ("the Trust Fund") in view of the proposed devolution of the approving authority for the application of part of the Trust Fund from the Chief Executive in Council ("CE in C") to the Secretary for Commerce and Economic Development ("SCED") under the Bill. The Administration advised that — (a) OPC at present had no specific or concrete plans to carry out its functions in other places and its current priority was to undertake the necessary work for outsourcing the retail, dining and entertainment ("RDE") zone in the lower park to private developer(s) and strengthen its financial position. The proposed amendment sought to allow flexibility for OPC to promote conservation and education to the wider community, provide holistic leisure experiences by going beyond OP's physical boundary to other places, even outside Hong Kong, as well as pursue exchange and cooperation with other conservation institutions; and | | | |

| | | (b) the Trust Fund was established on 1 July 1987 consisting of a donation of \$200 million from The Hong Kong Jockey Club mainly to support capital expenditure of development projects in OP. All donations received by OPC should be credited to the Trust Fund. OPC could apply the Trust Fund for, among others, the promotion of its functions in accordance with the stipulations in the Ocean Park Corporation Ordinance (Cap. 388) and approval of the CE in C would be required if the principal money was applied for purposes other than capital expenditure of development projects. OPC so far had not received any donation since the establishment of the Trust Fund. With the new positioning of OPC focusing on conservation and education under the future strategy for OP ("the Strategy"), it was envisaged that the capital expenditure to be incurred by OPC for development projects would be reduced and more would be spent on conservation and education initiatives, and that the Strategy would help bring in donations for supporting OPC's work in those two areas. The Administration was requested to provide further information on item (a). | |
| 001705 – 002126 | Chairman Ir Dr LO Wai-kwok Administration | Noting that the Bill would repeal the OP Bylaw ("the Bylaw") which conferred upon OPC the power to take various enforcement actions against suspected contraventions, Ir Dr LO Wai-kwok enquired about the ways to regulate patron order after the repeal of the Bylaw. The Administration advised that as the Bylaw would create confusion as to which party (i.e. OPC or the developers or operators) would have the responsibility and authority for enforcement under the new mixed mode of operation, it was proposed to repeal the Bylaw to avoid such confusion. Indeed, OPC rarely resorted to enforcement actions under the Bylaw since the vast majority of contraventions or suspected contraventions were dealt with by management means or persuasion and the Hong Kong Disneyland Resort ("HKDL") also did not have a bylaw in place for similar purpose. After the repeal of the Bylaw, conduct of visitors in OP would continue to be regulated through management means or persuasion as well as other applicable laws. | |

As OPC's current priority was to focus its work on repositioning OP itself for achieving financial sustainability with no concrete plans at present to carry out its functions in other places or undertake a major campaign for soliciting donation, relevant revenue projection would not be available at this stage. In any case, the carrying out of functions outside Hong Kong would only generate a small portion of OPC's income. The proposed amendment on the Trust Fund and OPC's power to carry out functions outside Hong Kong sought to provide flexibility for OPC's future operation and enable it to generate more income at opportune juncture. | |

With the passage of the Bill, it was targeted to launch the tendering exercise for outsourcing by the end of 2021, with the first upfront payment received by financial year 2022-2023. Subject to the development plan(s) of the private investor(s), it was expected that the new RDE zone would commence operation in financial year 2026-2027 and OPC would start receiving the rent/ revenue share derived by then. Meanwhile, OPC was striving to control cost and open up more sources of revenue. | |
| | | Mr CHUNG was concerned about the long timeframe taken to commence the RDE zone after entering into the outsourcing contracts, which would undermine the desire of investment. Moreover, the contract duration should be long enough to allow private operators to recover the investment made. | |
| | | The Administration advised that the said timeframe covered the periods for demolishing old facilities and constructing the new RDE facilities. Before the commencement of operation of the RDE zone, OPC would be provided with a time-limited subvention of not more than \$280 million per year for its conservation and education initiatives for four financial years between 2022-2023 and 2025-2026 to tide over its financial need in the short to medium term. | |
