- 2. <u>The Bills Committee</u> requested the Administration to:
 - (a) consider amending the definition of "family member" in the Personal Data (Privacy) (Amendment) Bill 2021 ("the Bill") to cover cohabiting partners;
 - (b) consider adding a provision to enable the Hong Kong Police Force ("the Police") to exercise the powers of the Privacy Commissioner for Personal Data ("the Commissioner") specified under the proposed new section 66D to carry out a specified investigation;
 - (c) provide case law on the meanings of "harassment, molestation, pestering, threat and intimidation" in the proposed new section 64(6)(a);
 - (d) provide examples of provisions in existing legislation which are similar to the proposed new section 64(5)(b), which seeks to provide that a person is taken to have established a matter that needs to be established for the purpose of a defence if the contrary is not proved by the prosecution beyond reasonable doubt; and

(e) provide case law on the meaning of "reckless" in the proposed new sections 64(3A) and (3C).
