### LEGISLATIVE COUNCIL BRIEF

### SUPPLEMENTARY APPROPRIATION (2019-2020) BILL

### INTRODUCTION

Α

At the meeting of the Executive Council on 20 October 2020, the Council ADVISED and the Chief Executive ORDERED that the Supplementary Appropriation (2019-2020) Bill, at **Annex A**, seeking approval for supplementary appropriation of \$62,596,672,879.91 from the general revenue for the services of the Government in the 2019-2020 financial year, should be introduced into the Legislative Council (LegCo).

### JUSTIFICATIONS AND BACKGROUND

- 2. The Appropriation Ordinance 2019 approved the expenditure of a total sum of \$515,794,785,000 from the general revenue for the services of the Government in the 2019-2020 financial year and the provision for each head of expenditure as provided for in the 2019-2020 estimates of expenditure.
- 3. In the course of the 2019-2020 financial year, the Government has either sought the LegCo Finance Committee's approval for, or approved under delegated authority, supplementary provisions for various heads of expenditure mainly for meeting additional expenses arising from the injections into Anti-epidemic Fund and the Research Endowment Fund, the 2019-2020 civil service pay adjustment and the disciplined services overtime allowance, as well as the requirements for one month's rent payments for tenants/licencees living in the rental units of the Hong Kong Housing Authority and the Hong Kong Housing Society. required under section 8(8) of the Public Finance Ordinance (PFO), the Government has provided quarterly updates to LegCo on supplementary provisions approved.

4. The annual accounts for the 2019-2020 financial year have been finalised. In accordance with section 9 of the PFO\*, we need to introduce a Supplementary Appropriation Bill into LegCo as soon as practicable. The purpose is to reconcile the differences between the sums originally appropriated for each head of expenditure under the General Revenue Account and the actual expenditure if these sums are exceeded.

# THE SUPPLEMENTARY APPROPRIATION (2019-2020) BILL (THE BILL)

5. For 28 of the 84 heads of expenditure under the General Revenue Account, the actual expenditure for the 2019-2020 financial year exceeded the original appropriation by a total of \$62,596,672,879.91, as detailed in **Annex B**. Accordingly, the Bill provides for a supplementary appropriation of this amount over and above the sum appropriated by the Appropriation Ordinance 2019.

#### 1. Short title

This Ordinance may be cited as the Supplementary Appropriation (2019–2020) Ordinance.
