**SMOKING (PUBLIC HEALTH) ORDINANCE  
(AMENDMENT OF SCHEDULE 2) ORDER 2021**

**INTRODUCTION**

On 12 August 2021, the Secretary for Food and Health (“SFH”), in exercise of the power under section 16A of the Smoking (Public Health) Ordinance (Cap. 371) (“Cap. 371”), made the Smoking (Public Health) Ordinance (Amendment of Schedule 2) Order 2021 (“the Amendment Order”), at **Annex A**, to designate three bus interchanges (“BIs”) and adjoining facilities leading to expressways or tunnels in Hong Kong as statutory no smoking areas (“NSAs”) and reflect the changes in two BIs and adjoining facilities which are already designated as NSAs.

**JUSTIFICATIONS**

**Background**

2. To protect public health, it is the established policy of the Government to discourage smoking, contain the proliferation of tobacco use and protect the public from passive smoking. Over the past three decades, we have adopted a progressive and multi-pronged approach comprising legislation, publicity, education, enforcement, smoking cessation and taxation to step up tobacco control, having regard to the expectation and acceptance of the community. With the concerted efforts by the Government and other stakeholders over the years, smoking prevalence among persons aged 15 and above in Hong Kong has dropped from over 20% in the 1980s to around 10% in recent years.

**Designation of NSAs**

3. Cap. 371 and its subsidiary legislation provide the legal framework for restricting the use, sale and promotion of tobacco products. Under Cap. 371, any person who smokes or carries a lighted cigarette, cigar or pipe in areas designated as no smoking areas (in contravention of *section 3*) or in public transport carriers (in contravention of *section 4*) commits an offence. Part 1 of Schedule 2 to Cap. 371 specifies a number of designated NSAs. According to section 16A of Cap.

371, SFH may by order published in the Gazette amend the Schedules.

4. Over the past decades, we have been progressively stepping up tobacco control efforts on all fronts having regard to the expectation and level of acceptance of our community. Amongst other measures, we have extended the smoking ban to the following 11 BIs at tunnel portal areas through previous exercises of amending Schedule 2 to Cap. 371 in 2016 and 2018 respectively –

- (a) Cross-Harbour Tunnel Bus Interchange;
- (b) Lion Rock Tunnel Bus Interchange;
- (c) Shing Mun Tunnel Bus Interchange;
- (d) Eastern Harbour Crossing Bus Interchange;
- (e) Western Harbour Crossing Bus Interchange;
- (f) Tate's Cairn Tunnel Bus Interchange;
- (g) Tai Lam Tunnel Bus Interchange;
- (h) Tsing Sha Highway Bus Interchange;
- (i) Tuen Mun Road Bus Interchange;
- (j) Lantau Toll Plaza Bus Interchange; and
- (k) Aberdeen Tunnel Bus Interchange.

5. Enforcement at these designated NSAs was largely smooth and the smoking ban in these areas was welcomed by the public in general.

### **Smoking Ban at Three BIs Leading to Expressways or Tunnels**

6. According to the Transport Department, there are 14 BIs that lead to expressways or tunnels, of which the following three have not yet been designated as NSAs–

- (a) Tuen Mun-Chek Lap Kok Tunnel Bus Interchange;
- (b) Fanling Highway Bus Interchange; and
- (c) Tseung Kwan O Tunnel Bus Interchange.

There are about 6 to 30 bus routes at each of these three BIs for passenger interchange.

7. Subsequent to the last designation exercise in 2018, we propose to amend Schedule 2 to Cap.371 to extend the statutory smoking ban to the abovementioned three BIs and adjoining facilities leading to expressways or tunnels and reflect the changes in two BIs and adjoining facilities which are already designated as NSAs, namely Cross Harbour Tunnel Bus Interchange and

Eastern Harbour Crossing Bus Interchange.

## **IMPLEMENTATION**

8. The exact boundary of NSAs is shown coloured orange and edged red on the plans of the BIs at **Annex B** signed by SFH. The proposed NSAs will cover the boarding and waiting areas of the BIs, as well as the areas that passengers will pass by in the course of accessing and interchanging among different bus routes.

9. To facilitate implementation, the Tobacco and Alcohol Control Office (“TACO”) under the Department of Health (“DH”) will arrange to display signs, publicity materials, and other demarcations including markings on the ground as appropriate to indicate clearly and visibly to the public the boundaries of the NSAs, having regard to their respective physical settings. The plans showing the boundaries of the NSAs will be posted at prominent positions such as the main entrances and exits.

10. After the legislative amendments come into operation on 31 December 2021, TACO will undertake enforcement actions at these locations through inspection and issue of fixed penalty notice under the Fixed Penalty (Smoking Offences) Ordinance (Cap. 600) to those who contravene the statutory smoking ban.

## **THE AMENDMENT ORDER**

11. The Amendment Order amends Part 1 of Schedule 2 to Cap. 371 to designate the three BIs and adjoining facilities leading to expressways or tunnels in Hong Kong as NSAs and reflect the changes in two BIs and adjoining facilities which are already designated as NSAs. Subject to negative vetting by the LegCo, the Amendment Order will come into operation on 31 December 2021.

## **LEGISLATIVE TIMETABLE**

12. The legislative timetable is as follows –

Publication of Amendment Order in the Gazette	20 August 2021
Tabling at LegCo	25 August 2021

## **IMPLICATIONS OF THE PROPOSAL**

13. The Amendment Order is in conformity with the Basic Law, including the provisions concerning human rights. It will not affect the current binding effect of the principal ordinance. Additional staffing and financial implications, if any, arising from the implementation of the proposal will be absorbed within the existing manpower and financial resources of DH. It has insignificant family and no economic, environmental, competition, sustainability or gender implications.

## **PUBLICITY**

14. An information paper on the details of the amendments has been issued to 18 District Councils. All plans of the NSAs of the BIs and adjoining facilities have been deposited in the Land Registry for inspection by the public. They will also be posted on TACO's website before the amendments take effect.

## Smoking (Public Health) Ordinance (Amendment of Schedule 2) Order 2021

(Made by the Secretary for Food and Health under section 16A of the Smoking (Public Health) Ordinance (Cap. 371))

### 1. Commencement

This Order comes into operation on 31 December 2021.

### 2. Smoking (Public Health) Ordinance amended

  - (i) coloured orange and edged red;
  - (ii) coloured orange stippled black and edged red; and
  - (iii) coloured orange hatched black and edged red,on Plan No. DH/TCO/E-006V1, signed by the Secretary on 12 August 2021 and deposited in the Land Registry;
- (o) Tuen Mun-Chek Lap Kok Tunnel Bus Interchange, located at Tuen Mun Chek Lap Kok Tunnel Road, as shown coloured orange and edged red on Plan No. DH/TCO/T-009V1, signed by the Secretary on 12 August 2021 and deposited in the Land Registry.”


