

LEGISLATIVE COUNCIL BRIEF

PUBLIC HEALTH AND MUNICIPAL SERVICES DESIGNATION OF PUBLIC LIBRARY

INTRODUCTION

The Director of Leisure and Cultural Services, in his capacity as the Authority (“Authority”) under the Public Health and Municipal Services Ordinance Cap.132 (“the Ordinance”), manages and controls the libraries listed in the Schedule to the Designation of Libraries Order (Cap. 132 sub. leg.O). Under Section 105K of the Ordinance, the Authority may, by order published in the Gazette, designate any building, or part of a building, as a library.

2. We propose to amend the Schedule to the Designation of Libraries Order (Cap. 132 sub. leg.O) as follows:-

By repealing item 74 –

“74. Shop Nos. G15 and G16, Ground Floor, Dawning Views Shopping Plaza, 23 Yat Ming Road, Fanling.”

and substituting item 74 –

“74. Shop Nos. 104A and 105A, First Floor, Dawning Views, 23 Yat Ming Road, Fanling.”

JUSTIFICATIONS

3. The amendments to the Schedule to the Designation of Libraries Order (Cap. 132 sub. leg.O) as proposed in paragraph 2 shall come into operation on 28 December 2021. They enable the Authority to enforce the regulations relating to this public library for proper management. The existing Fanling South Public Library located at Shop Nos. G15 and G16, Ground Floor, Dawning Views Shopping Plaza, 23 Yat Ming Road, Fanling will be closed and ceased operation upon the commissioning of the new library. The new library will be opened for public use with effect from 28 December 2021.

AMENDMENT OF SCHEDULE TO THE DESIGNATION OF LIBRARIES ORDER (Cap. 132 sub. leg. O)

4. The Order at Annex A amends the Schedule to the Designation of Libraries Order to update the list of public libraries.

Explanatory Note

This Order—

- (a) cancels the designation of Shop Nos. G15 and G16, Ground Floor, Dawning Views Shopping Plaza, 23 Yat Ming Road, Fanling as a library; and
 - (b) designates Shop Nos. 104A and 105A, First Floor, Dawning Views, 23 Yat Ming Road, Fanling as a library.
2. As a result of the designation, the management and control of the library mentioned in paragraph 1(b) is vested in the Director of Leisure and Cultural Services. The Director may also exercise other statutory functions under the Public Health and Municipal Services Ordinance (Cap. 132) in respect of that library.
