WAIVERS AND CONCESSIONS OF GOVERNMENT FEES AND CHARGES

INTRODUCTION

At the meeting of the Executive Council on 24 August 2021, the Council ADVISED and the Chief Executive ORDERED that the following regulations and order should be made –

- (a) the Shipping and Port Control (Amendment) Regulation 2021, at <u>Annex A</u>, to extend, for one more year from 1 October 2021, the waiving of port facilities and light dues payable for ocean-going vessels and high speed crafts;
- (b) the Port Control (Cargo Working Areas) (Amendment) Regulation 2021 and the Port Control (Cargo Working Areas) (Amendment) (Fee Concessions) Regulation 2019 (Amendment) Regulation 2021, at <u>Annexes B1</u> and <u>B2</u> respectively, to extend, for one more year from 1 October 2021, the waiving of vehicle entry ticket fees for the first hour payable by trucks entering the Public Cargo Working Areas ("PCWAs") and operation area permit fees payable by PCWA operators;
- the Road Traffic (Registration and Licensing of Vehicles) (Amendment) Regulation 2021 and the Road Traffic (Registration and Licensing of Vehicles) (Amendment) (Fee Concessions) Regulation 2019 (Amendment) Regulation 2021, at <u>Annexes C1</u> and <u>C2</u> respectively, to extend, for one more year from 30 December 2021, the waiving of closed road permit fees for cross boundary goods vehicles, buses and hire cars; and vehicle licence fees for goods vehicles, special purpose vehicles, trailers, taxies, non-franchised public buses, private buses, light buses (both public and private) and hire cars;

- (d) the Road Traffic Ordinance (Amendment of Schedule 3) Order 2021, at **Annex D**, to extend, for one more year from 30 December 2021, the waiving of vehicle examination fees payable in respect of the first vehicle examinations for the renewal of vehicle licences of goods vehicles, special purpose vehicles, trailers, taxies, non-franchised public buses, franchised public buses, private buses, light buses (both public and private) and hire cars that take place within a specified period¹;
- the Hong Kong Air Navigation (Fees) (Amendment) Regulation 2021 and the Hong Kong Air Navigation (Fees) (Amendment) Regulation 2020 (Amendment) Regulation 2021, at <u>Annexes E1</u> and <u>E2</u> respectively, to extend, for one more year from 1 October 2021, the waiving of the fees payable for the renewal of air operator's certificate, issue or renewal of certificate of airworthiness and renewal of approval of maintenance organisation;
- (f) the Marine Fish Culture (Amendment) Regulation 2021, at <u>Annex F</u>, to extend the waiving of marine fish culture licence fees for one more year from 1 October 2021;
- (g) the Public Health (Animals and Birds) (Licensing of Livestock Keeping) (Amendment) Regulation 2021 and the Public Health (Animals and Birds) (Licensing of Livestock Keeping) (Amendment) (Fee Concessions) Regulation 2019 (Amendment) Regulation 2021, at <u>Annexes G1</u> and <u>G2</u> respectively, to extend the reduction of the fees for the renewal of livestock keeping licences for one more year from 1 October 2021;
- (h) the Sewage Services (Trade Effluent Surcharge) (Amendment) Regulation 2021, at <u>Annex H</u>, to extend the waiving of trade effluent surcharge for one more year from 1 January 2022;
- (i) the Waterworks (Amendment) (No. 2) Regulation 2021, at <u>Annex I</u>, to extend, for four more months from 1 December 2021, the 75% reduction of the charge for fresh water supplied for non-domestic purposes, subject to a monthly cap of \$20,000 for each meter covered by a water bill;

- (j) the Sewage Services (Sewage Charge) (Amendment) (No. 2) Regulation 2021, at <u>Annex J</u>, to extend, for four more months from 1 December 2021, the 75% reduction of the sewage charge for fresh water supplied for non-domestic purposes, subject to a monthly cap of \$12,500 for each meter covered by a water bill;
- (k) the Mines (Safety) (Amendment) Regulation 2021 and the Mines (Safety) (Amendment) Regulation 2020 (Amendment) Regulation 2021, at <u>Annexes K1</u> and <u>K2</u> respectively, to extend the waiving and reduction of mine blasting certificate fees for one more year from 1 October 2021;
- (l) the Dangerous Goods (General) (Amendment) Regulation 2021, at **Annex L**, to extend the waiving of Category 1 dangerous goods licence and permit fees for one more year from 1 October 2021;
- (m) the Dangerous Goods (Government Explosives Depots) (Amendment) Regulation 2021, at <u>Annex M</u>, to extend, for one more year from 1 October 2021, the waiving of the fees payable for storage in a Government Explosives Depot and delivery from a Government Explosives Depot of explosives (Category 1 dangerous goods);
- (n) the Building (Minor Works) (Fees) (Amendment) Regulation 2021 and the Building (Minor Works) (Fees) (Amendment) (Fee Concessions) Regulation 2019 (Amendment) Regulation 2021, at <u>Annexes N1</u> and <u>N2</u> respectively, to extend the waiving and reduction of certain fees related to the registration of registered minor works contractors for one more year from 21 October 2021;
- (o) the Electricity (Registration) (Amendment) Regulation 2021 and the Electricity (Registration) (Amendment) Regulation 2020 (Amendment) Regulation 2021, at **Annexes O1** and **O2** respectively, to extend the reduction of the fees for application for registration or renewal of registration as an electrical contractor or electrical worker for one more year from 1 October 2021;

- (p) the Karaoke Establishments (Fees) (Amendment) Regulation 2021 and the Karaoke Establishments (Fees) (Amendment) (Fee Concessions) Regulation 2019 (Amendment) Regulation 2021, at <u>Annexes P1</u> and <u>P2</u> respectively, to extend the waiving and reduction of karaoke establishment licence and permit fees for one more year from 1 October 2021; and
- (q) the Travel Agents (Amendment) Regulation 2021 and the Travel Agents (Amendment) (Fee Concessions) Regulation 2019 (Amendment) Regulation 2021, at <u>Annexes Q1</u> and <u>Q2</u> respectively, to extend the waiving of travel agents licence fees from 1 October 2021 until the earlier of 30 September 2022 or the day before the repeal of the Travel Agents Regulations (Cap. 218 sub. leg. A)².
- 2. Separately, the following regulations should also be made by the Secretary for Financial Services and the Treasury³ ("SFST"), Secretary for Transport and Housing, Secretary for Food and Health, Secretary for Home Affairs ("SHA") and Construction Industry Council ("CIC") (with the approval of the Secretary for Development) respectively
 - (a) the Merchant Shipping (Local Vessels) (Fees) (Amendment) Regulation 2021 and the Merchant Shipping (Local Vessels) (Fees) (Amendment) (Fee Concessions) Regulation 2019 (Amendment) Regulation 2021, at <u>Annexes R1</u> and <u>R2</u> respectively, to extend, for one more year from 1 November 2021, the waiving of the fees payable for permits to remain and vessel licences;
 - (b) the Road Traffic (Public Service Vehicles) (Amendment) Regulation 2021 and the Road Traffic (Public Service Vehicles) (Amendment) (Fee Concessions) Regulation 2019 (Amendment) Regulation 2021, at <u>Annexes S1</u> and <u>S2</u> respectively, to extend, for one more year from 30 December 2021, the waiving of the fees payable for passenger service licences, passenger service licence certificates and hire car permits;

- (c) the Dutiable Commodities (Liquor Licences) (Fees) (Amendment) Regulation 2021 and the Dutiable Commodities (Liquor Licences) (Fees) (Amendment) (Fee Concessions) Regulation 2019 (Amendment) Regulation 2021, at <u>Annexes T1</u> and <u>T2</u> respectively, to extend, for one more year from 1 October 2021, the waiving and reduction of the fees payable in respect of liquor licences;
- (d) the Places of Public Entertainment (Fee Concessions) (Amendment) Regulation 2021, at <u>Annex U</u>, to extend, for one more year from 1 October 2021, the waiving of the fees payable for cinema licences and licences for other places of public entertainment (such as family amusement centres, exhibition venues, etc.); and
- (e) the Construction Workers Registration (Fees) (Amendment) Regulation 2021, at <u>Annex V</u>, to extend, for one more year from 1 October 2021, the waiving of the fees payable for construction workers' registrations.

JUSTIFICATIONS

3. Although the pandemic situation has shown signs of easing recently, the overall economic development remains uncertain and it will possibly take some time for businesses to fully recover. To sustain the support for businesses and provide relief to a wide range of sectors, there is a need to extend the 75% reduction of water and sewage charges for fresh water supplied for non-domestic purposes for four more months and 34 other groups of waivers/concessions of government fees and charges for one more year. Separately, there is also a need for the CIC, a statutory body, to extend a fee waiver for a further year to help out the construction industry. Of these total 36 groups of waivers/concessions of fees and charges, 24 groups require the making of subsidiary legislation either by the Chief Executive, Chief Executive in Council or the relevant Directors of Bureau. The remaining 12 groups can be implemented by the designated authorities under relevant ordinances or administratively.

WAIVERS/CONCESSIONS OF FEES AND CHARGES

- 4. The 36 groups of waivers/concessions of fees and charges will benefit a wide range of sectors from aviation, maritime, logistics, agriculture and fisheries, retail, catering, construction to tourism and entertainment. Details of the waivers/concessions, together with the revenue forgone, estimated number of beneficiaries, and implementation dates/periods are at **Annex W**.
- 5. For transaction-based fees (e.g. port facilities and light dues payable upon each entry), waiver will be given for each transaction to be made during the waiver period. For other types of fees payable with a validity period such as licence fees, permit fees, registration fees, etc., the fees payable in respect of the first issue or renewal of licences, permits or registrations that take effect during the waiver/concession period, or where appropriate upon application made during the waiver/concession period if such fees are statutorily required to be paid upon application, will be waived/reduced for a maximum period of one year⁴. waiver/concession does not apply to those licences, permits or registrations which take effect before and will expire during the relevant waiver/concession period. Holders of these licences or permits, or registered persons will enjoy the waiver/ concession if and when they next renew or apply to renew (as the case may be) their licences, permits or registrations during the waiver/concession period.
- 6. Refund will be considered by the relevant departments for those licences, permits or registrations which take effect (or the application for which is made) before the waiver/concession period, are valid for more than one year, and with an expiry date falling beyond the respective waiver/concession periods. Holders of these licences or permits, or registered persons will be refunded direct or upon application the relevant fees and charges already paid on a pro-rata basis by reference to the waiver/concession periods⁴. Details would be worked out by the relevant departments.

⁴ The principles on a maximum period of one year of waiver/concession and refund as described in paragraphs 5 and 6 above apply to all concerned waivers/concessions except for two groups, namely (a) renewal of air operator's certificate and (b) the fees under the CIC, both of which cover multi-year fees. For (a), the fees payable during the one-year waiver period will be waived for the whole period of the multi-year renewal and the full amount of fees already paid will be refunded. For (b), the fees payable during the one-year waiver

period will be waived for the whole period of the multi-year registration/renewal and the full amount of fees already paid will not be refunded. Details are set out in the related regulations.

7. All of the waivers/concessions will be valid for one year, except for the 75% reduction of water and sewage charges for fresh water supplied for non-domestic purposes which will be valid for four months. The majority of waivers/concessions will take effect from 1 October 2021 while the remaining ones will progressively take effect on a later date upon the respective expiry of the existing waivers/concessions. Details of the waivers/concessions of fees and charges are set out in the ensuing paragraphs.

Aviation, Maritime and Logistics

- 8. The Shipping and Port Control (Amendment) Regulation 2021, at Annex A, was made under the Shipping and Port Control Ordinance (Cap. 313) to extend, for one more year from 1 October 2021, the waiving of the port facilities and light dues payable for ocean-going vessels and high speed crafts.
- 9. The Merchant Shipping (Local Vessels) (Fees) (Amendment) Regulation 2021 and the Merchant Shipping (Local Vessels) (Fees) (Amendment) (Fee Concessions) Regulation 2019 (Amendment) Regulation 2021, at Annexes R1 and R2 respectively, were made under the Merchant Shipping (Local Vessels) Ordinance (Cap. 548) to extend, for one more year from 1 November 2021, the waiving of the fees payable in respect of permits to remain and vessel licences.
- 10. The Port Control (Cargo Working Areas) (Amendment) Regulation 2021 and the Port Control (Cargo Working Areas) (Amendment) (Fee Concessions) Regulation 2019 (Amendment) Regulation 2021, at Annexes B1 and B2 respectively, were made under the Port Control (Cargo Working Areas) Ordinance (Cap. 81) to extend, for one more year from 1 October 2021, the waiving of the fees payable in respect of vehicle entry tickets for the first hour payable by trucks entering the PCWAs and operation area permits payable by PCWA operators.

- 11. The Road Traffic (Registration and Licensing of Vehicles) (Amendment) Regulation 2021 and the Road Traffic (Registration and Licensing of Vehicles) (Amendment) (Fee Concessions) Regulation 2019 (Amendment) Regulation 2021, at Annexes C1 and C2 respectively, were made under the Road Traffic Ordinance (Cap. 374) to extend, for one more year from 30 December 2021, the waiving of the fees payable in respect of closed road permits for cross boundary goods vehicles, buses and hire cars; and vehicle licences for goods vehicles, special purpose vehicles, trailers, taxies, non-franchised public buses, private buses, light buses (both public and private) and hire cars.
- 12. The Road Traffic Ordinance (Amendment of Schedule 3) Order 2021, at Annex D, was made under the Road Traffic Ordinance (Cap. 374) to extend, for one more year from 30 December 2021, the waiving of the fees payable in respect of the first vehicle examinations for the renewal of vehicle licences of goods vehicles, special purpose vehicles, trailers, taxies, non-franchised public buses, franchised public buses, private buses, light buses (both public and private) and hire cars that take place within a specified period¹.
- 13. The Road Traffic (Public Service Vehicles) (Amendment) Regulation 2021 and the Road Traffic (Public Service Vehicles) (Amendment) (Fee Concessions) Regulation 2019 (Amendment) Regulation 2021, at Annexes S1 and S2 respectively, were made under the Road Traffic Ordinance (Cap. 374) to extend, for one more year from 30 December 2021, the waiving of the fees payable in respect of passenger service licences, passenger service licence certificates and hire car permits.
- 14. The Hong Kong Air Navigation (Fees) (Amendment) Regulation 2021 and the Hong Kong Air Navigation (Fees) (Amendment) Regulation 2020 (Amendment) Regulation 2021, at Annexes E1 and E2 respectively, were made under the Air Navigation (Hong Kong) Order 1995 (Cap. 448 sub. leg. C) to extend, for one more year from 1 October 2021, the waiving of the fees payable in respect of the renewal of air operator's certificate, issue or renewal of certificate of airworthiness and renewal of approval of maintenance organisation.

Agriculture and Fisheries

- 15. The Marine Fish Culture (Amendment) Regulation 2021, at Annex F, was made under the Marine Fish Culture Ordinance (Cap. 353) to extend, for one more year from 1 October 2021, the waiving of the fees payable in respect of marine fish culture licences.
- 16. The Public Health (Animals and Birds) (Licensing of Livestock Keeping) (Amendment) Regulation 2021 and the Public Health (Animals and Birds) (Licensing of Livestock Keeping) (Amendment) (Fee Concessions) Regulation 2019 (Amendment) Regulation 2021, at Annexes G1 and G2 respectively, were made under the Public Health (Animals and Birds) Ordinance (Cap. 139) to extend, for one more year from 1 October 2021, the reduction of the fees payable in respect of the renewal of livestock keeping licences.

Retail and Catering

- 17. The Dutiable Commodities (Liquor Licences) (Fees) (Amendment) Regulation 2021 and the Dutiable Commodities (Liquor Licences) (Fees) (Amendment) (Fee Concessions) Regulation 2019 (Amendment) Regulation 2021, at Annexes T1 and T2 respectively, were made under the Dutiable Commodities Ordinance (Cap. 109) to extend, for one more year from 1 October 2021, the waiving and reduction of the fees payable in respect of liquor licences.
- 18. The Sewage Services (Trade Effluent Surcharge) (Amendment) Regulation 2021, at Annex H, was made under the Sewage Services Ordinance (Cap. 463) to extend the waiving of the trade effluent surcharge for one more year from 1 January 2022 to 31 December 2022.
- 19. The Waterworks (Amendment) (No. 2) Regulation 2021, at Annex I, was made under the Waterworks Ordinance (Cap. 102) to extend, for four more months from 1 December 2021, the 75% reduction of the charge for fresh water supplied for non-domestic purposes, subject to a monthly cap of \$20,000 for each meter covered by a water bill.

20. The Sewage Services (Sewage Charge) (Amendment) (No. 2) Regulation 2021, at Annex J, was made under the Sewage Services Ordinance (Cap. 463) to extend, for four more months from 1 December 2021, the 75% reduction of the sewage charge for fresh water supplied for non-domestic purposes, subject to a monthly cap of \$12,500 for each meter covered by a water bill.

Construction

- 21. The Mines (Safety) (Amendment) Regulation 2021 and the Mines (Safety) (Amendment) Regulation 2020 (Amendment) Regulation 2021, at Annexes K1 and K2 respectively, were made under the Mining Ordinance (Cap. 285) to extend, for one more year from 1 October 2021, the waiving and reduction of the fees payable in respect of mine blasting certificates.
- 22. The Dangerous Goods (General) (Amendment) Regulation 2021, at Annex L, was made under the Dangerous Goods Ordinance (Cap. 295) to extend, for one more year from 1 October 2021, the waiving of the fees payable in respect of Category 1 dangerous goods licences and permits.
- 23. The Dangerous Goods (Government Explosives Depots) (Amendment) Regulation 2021, at Annex M, was made under the Dangerous Goods Ordinance (Cap. 295) to extend, for one more year from 1 October 2021, the waiving of the fees payable in respect of the storage in a Government Explosives Depot and delivery from a Government Explosives Depot of explosives (Category 1 dangerous goods).
- 24. The Building (Minor Works) (Fees) (Amendment) Regulation 2021 and the Building (Minor Works) (Fees) (Amendment) (Fee Concessions) Regulation 2019 (Amendment) Regulation 2021, at Annexes N1 and N2 respectively, were made under the Buildings Ordinance (Cap. 123) to extend the waiving and reduction of certain fees related to the registration of registered minor works contractors for one more year from 21 October 2021 to 20 October 2022.

- 25. The Electricity (Registration) (Amendment) Regulation 2021 and the Electricity (Registration) (Amendment) Regulation 2020 (Amendment) Regulation 2021, at Annexes O1 and O2 respectively, were made under the Electricity Ordinance (Cap. 406) to extend the reduction of the application fee for registration or renewal of registration as an electrical contractor or electrical worker for one more year from 1 October 2021 to 30 September 2022.
- 26. The Construction Workers Registration (Fees) (Amendment) Regulation 2021, at Annex V, was made under the Construction Workers Registration Ordinance (Cap. 583) to extend, for one more year from 1 October 2021, the waiving of the fees payable to the CIC in respect of the registration and renewal of registration of construction workers.

Tourism and Entertainment

- 27. The Places of Public Entertainment (Fee Concessions) (Amendment) Regulation 2021, at Annex U, was made under the Places of Public Entertainment Ordinance (Cap. 172) to extend, for one more year from 1 October 2021, the waiving of the fees payable in respect of cinema licences and licences for other places of public entertainment (such as family amusement centres, exhibition venues, etc.).
- 28. The Karaoke Establishments (Fees) (Amendment) Regulation 2021 and the Karaoke Establishments (Fees) (Amendment) (Fee Concessions) Regulation 2019 (Amendment) Regulation 2021, at Annexes P1 and P2 respectively, were made under the Karaoke Establishments Ordinance (Cap. 573) to extend, for one more year from 1 October 2021, the waiving and reduction of the fees payable in respect of the karaoke establishment licences and permits.
- 29. The Travel Agents (Amendment) Regulation 2021 and the Travel Agents (Amendment) (Fee Concessions) Regulation 2019 (Amendment) Regulation 2021, at Annexes Q1 and Q2 respectively, were made under the Travel Agents Ordinance (Cap. 218) to extend the waiving of the fees payable in respect of travel agents licences from 1 October 2021 until the earlier of 30 September 2022 or the day before the repeal of the Travel Agents Regulations (Cap. 218 sub. leg. A)².

WAIVERS/CONCESSIONS OF LICENSING FEES NOT REQUIRING LEGISLATION

- 30. The extension of the following groups of waivers/concessions of licensing fees can be implemented by the Government administratively
 - (a) the FS has the power to extend the waiving and refunding of fees for hawker licences, general restaurant/marine restaurant/light refreshment restaurant/factory canteen licences, restricted food permits, fresh provision shop licences, bakery/siu mei and lo mei shop/composite food shop licences, food factory/frozen confection factory/milk factory/cold store licences, slaughterhouse licences; and fees for commercial bathhouse licences issued under the Public Health and Municipal Services Ordinance (Cap. 132);
 - (b) the SHA has the power to extend the waiving/reduction and refunding of fees for hotel and guesthouse licences as provided for under the Hotel and Guesthouse Accommodation (Fees) Regulations (Cap. 349 sub. leg. B), fees for certificate of compliance issued under the Clubs (Safety of Premises) (Fees) Regulations (Cap. 376 sub. leg. B), and fees for bedspace apartment licences issued under the Bedspace Apartments (Fees) Regulation (Cap. 447 sub. leg. B); and
 - (c) the SFST has the power to extend the waiving of the service fees payable under the Free Trade Agreement Transhipment Facilitation Scheme (including documentary processing fee and customs supervision fee), which are administrative fees in nature not specified in legislation.

The waivers/concessions of the above fees can therefore be implemented through administrative means and no subsidiary legislation will be required.

LEGISLATIVE TIMETABLE

31. The regulations and order will be published in the Gazette on 27 August 2021 and tabled in the Legislative Council ("LegCo") for negative vetting at the next sitting thereof after the publication.

32. The waivers/concessions should be implemented as soon as possible so as to benefit the targeted stakeholders. We therefore propose that the subsidiary legislation for extending the waivers/concessions of various fees and charges should take effect without waiting upon the expiry of the period required for negative vetting of the subsidiary legislation by the LegCo.

IMPLICATIONS OF THE PROPOSAL

- 33. The proposal is in conformity with the Basic Law, including the provisions concerning human rights. The proposal will not affect the binding effect of existing provisions of the relevant ordinances and their subsidiary legislation. It has no productivity, environmental, sustainability, gender or family implications. As for economic implications, the proposal should help reduce the operating costs of enterprises, especially the small and medium enterprises, in a number of sectors, thereby rendering support to the relevant enterprises to counter the challenges from external and local economic environment.
- 34. Civil service implications, if any, will be absorbed within the existing provision of the relevant bureaux/departments. The estimated revenue forgone arising from the extension of waivers/concessions of fees and charges to the Government and the CIC are \$2,036 million and \$10 million respectively.

PUBLIC CONSULTATION

35. The Government has decided to extend the above waivers/concessions of fees and charges to sustain the support for businesses and individuals after taking into account views from different sectors on the difficulties they encountered in recent months.
