- <sup>1</sup> In accordance with rule 4(c) of the House Rules, the President decides the priority of Members to ask questions at CE's Q&A Sessions and CE's Question Time. The rule provides that at Q&A Sessions, Members who have asked the least number of questions at previous sessions within the term of the Legislative Council are given priority to ask questions. Where there are Members with equal priority, the President will have the discretion to decide whom to be called first to ask a question.
