Hon Claudia MO rose to request the President's permission for her to move an adjournment motion under RoP 16(2). The meeting was suspended for the President to consider the request. After consideration, the President did not accede to Ms MO's request and explained his decision to the Council.

First Reading and Second Reading (debate to be adjourned)

Supplementary Appropriation : Secretary for Financial Services (2019-2020) Bill
 Secretary for Financial Services and the Treasury

After the Bill was read the first time and ordered to be set down for Second Reading under RoP 53(3), the public officer moved the Second Reading of the Bill. The question on the Second Reading of the Bill was proposed. In accordance with RoP 54(4), the debate was adjourned and the Bill was referred to the House Committee.

Second Reading (debate to resume), consideration by committee of the whole Council and Third Reading

Freight Containers (Safety) : Secretary for Transport and (Amendment) Bill 2019Housing

The Second Reading debate on the Bill resumed. After Members and the public officer had spoken, the question on the Second Reading of the Bill was put and agreed to (details of division in **Appendix 2**). The Bill was read the second time and committed to a committee of the whole Council.

The Council became committee of the whole Council and considered the Bill. The question that clauses 1 to 12 stand part of the Bill was proposed. After Members and the public officer had spoken, the question that clauses 1 to 12 stand part of the Bill was put and agreed to (details of division in **Appendix 3**).

The Bill was ordered to be set down for Third Reading under RoP 59. The question on the Third Reading of the Bill was proposed. The Bill was read the third time and passed.
