Attendance

Laying of Papers on the Table of the Council

Four items of subsidiary legislation laid on the Table of the Council and eight other papers tabled under Rule 21(2) of the Rules of Procedure (“RoP”) were in **Appendix 1**.

Questions

Six oral questions (i.e. Questions 1 to 6) were put by the Members, and oral replies given by the public officers to the main and supplementary questions put by Members.

Written replies to Questions 7 to 22 were supplied to Members.

Government Bills

First Reading and Second Reading (debate to be adjourned)

- Employment (Amendment) Bill 2021 : Secretary for Labour and Welfare
- Revenue (First Registration Tax and Licence Fees for Motor Vehicles) Bill 2021 : Secretary for Transport and Housing
- Public Offices (Candidacy and Taking Up Offices) (Miscellaneous Amendments) Bill 2021 : Secretary for Constitutional and Mainland Affairs
- Revenue (Stamp Duty) Bill 2021 : Secretary for Financial Services and the Treasury
- Revenue (Tax Concessions) Bill 2021 : Secretary for Financial Services and the Treasury

After the Bills were read the first time and ordered to be set down for Second Reading under RoP 53(3), the public officers moved the Second Reading of the above five Bills respectively. The questions on the Second Reading of the Bills were proposed respectively. In accordance with RoP 54(4), the debates were adjourned and the Bills were referred to the House Committee.

Second Reading (debate to resume), consideration by committee of the whole Council and Third Reading

- Arbitration (Amendment) Bill 2021 : Secretary for Justice

The Second Reading debate on the Bill resumed. The question on the Second Reading of the Bill was put and agreed to. The Bill was read the second time and committed to a committee of the whole Council.

The Council became committee of the whole Council and considered the Bill. The question that clauses 1 to 7 stand part of the Bill was proposed, put and agreed to.

The Council then resumed. The public officer reported the Bill to the Council without amendment. The question on the public officer's motion that the report made under RoP 58(12) be adopted by this Council was proposed, put and agreed to. The Bill was ordered to be set down for Third Reading under RoP 59. The question on the Third Reading of the Bill was proposed, put and agreed to. The Bill was read the third time and passed.

- Stamp Duty (Amendment) Bill 2020 : Secretary for Financial Services and the Treasury

The Second Reading debate on the Bill resumed. After Members and the public officer had spoken, the question on the Second Reading of the Bill was put and agreed to. The Bill was read the second time and committed to a committee of the whole Council.

The Council became committee of the whole Council and considered the Bill. The question that clauses 1 to 10 stand part of the Bill was proposed, put and agreed to.

The Council then resumed. The public officer reported the Bill to the Council without amendment. The question on the public officer's motion that the report made under RoP 58(12) be adopted by this Council was proposed, put and agreed to. The Bill was ordered to be set down for Third Reading under RoP 59. The question on the Third Reading of the Bill was proposed, put and agreed to. The Bill was read the third time and passed.

- Sex Discrimination (Amendment) Bill 2020 : Secretary for Constitutional and Mainland Affairs

The Second Reading debate on the Bill resumed. After Members and the public officer had spoken, the question on the Second Reading of the Bill was put and agreed to. The Bill was read the second time and committed to a committee of the whole Council.

The Council became committee of the whole Council and considered the Bill. The provisions of the Bill and amendments thereto were debated and voted in accordance with the relevant debate and voting arrangements and the relevant provisions of RoP.
