Government Bill

First Reading and Second Reading (debate to be adjourned)

- National Flag and National Emblem : Secretary for Constitutional and
(Amendment) Bill 2021 Mainland Affairs

After the Bill was read the first time and ordered to be set down for Second Reading under RoP 53(3), the public officer moved the Second Reading of the Bill. The question on the Second Reading of the Bill was proposed. In accordance with RoP 54(4), the debate was adjourned and the Bill was referred to the House Committee.

Member's Motion on Subsidiary Legislation under the Interpretation and General Clauses Ordinance

Proposed resolution to extend the period for amending subsidiary legislation (L.N. 115 to L.N. 119 of 2021)

Hon WONG Ting-kwong moved the motion. The question on the motion was proposed, put and agreed to.

Member's Bill

Second Reading (debate to resume), consideration by committee of the whole Council and Third Reading

- Organized and Serious Crimes : Hon Elizabeth QUAT
(Amendment) Bill 2021

The Second Reading debate on the Bill resumed. After the public officer and Hon Elizabeth QUAT had spoken, the question on the Second Reading of the Bill was put and agreed to. The Bill was read the second time and committed to a committee of the whole Council.

The Council became committee of the whole Council and considered the Bill. The question that clauses 1 to 3 stand part of the Bill was proposed. After Members had spoken, the question that clauses 1 to 3 stand part of the Bill was put and agreed to.

The Council then resumed. Hon Elizabeth QUAT reported the Bill to the Council without amendment. The question on Hon Elizabeth QUAT's motion that the report made under RoP 58(12) be adopted by this Council was proposed, put and agreed to. The Bill was ordered to be set down for Third Reading under RoP 59. The question on the Third Reading of the Bill was proposed, put and agreed to. The Bill was read the third time and passed.
