**Council meeting of 9 June 2021**

**Amendment to Hon Jeffrey LAM's motion on  
"Rebuilding public confidence"**

Further to LC Paper No. CB(3) 575/20-21 issued on 21 May 2021, the President has given permission for Dr Hon Junius HO to move an amendment to Hon Jeffrey LAM's motion, and has directed that the amendment be printed in the terms in which it was handed in on the Agenda of the Council.

2. The President will order a joint debate on the above motion and the amendment. I set out below the relevant proceedings in which the President will:

- (a) call upon the motion mover to speak and move the motion;
- (b) propose the question on the motion;
- (c) call upon the Member who wishes to move an amendment to the motion to speak, but no amendment is to be moved at this stage;
- (d) call upon the public officer(s) to speak;
- (e) invite other Members to speak;
- (f) call upon the motion mover to speak on the amendment;

- (g) call upon the public officer(s) to speak again;
- (h) invite the amendment mover to move his amendment and forthwith propose and put to vote the question on the amendment; and
- (i) call upon the motion mover to reply, and then put to vote the question on the motion, or the motion as amended, as the case may be.

3. For Members' reference, the terms of the original motion and the marked-up version of the amendment are set out in the **Appendix**.

4. Members are reminded that in accordance with Appendix IIIA to the House Rules, the **maximum duration of this joint debate (including voting) is four hours**. The motion mover will have a total of 10 minutes to make introductory speech and reply, and another five minutes to speak on the amendment(s). The mover(s) of the amendment(s) and other Members may each speak once up to a maximum of five minutes. The public officer(s) will not be subject to any speaking time limit.

5. Members are also invited to note that the above motion was originally scheduled for the Council meeting of 2 June 2021 and has now been rescheduled to the Council meeting of 9 June 2021.

**Motion debate on

**1. Hon Jeffrey LAM’s original motion**

That this Council urges the Government to formulate feasible policy measures to boost the economy and improve people’s livelihood, establish positive interaction with the public and connect with young people, thereby rebuilding public confidence in the Government; specific proposals include:

- (1) setting up an Economic Stimulation Committee to formulate action plans for post-pandemic economic recovery;
- (2) accountability officials strengthening their communication with various stakeholders in the process of formulating major economic and livelihood-related policies and, by way of visiting various districts, organizing and participating in forums or meetings, utilizing social platforms, etc., extensively collecting public views and holding discussions with the public; and
- (3) establishing a Youth Development Coordination Unit for one-stop processing of the work related to actively addressing young people’s concerns about education, career pursuit and home ownership, and encouraging their participation in politics as well as public policy discussion and debate.

**2. Motion as amended by Dr Hon Junius HO**

That this Council urges the Government to formulate feasible policy measures to boost the economy and improve people’s livelihood, establish positive interaction with the public and connect with young people, thereby rebuilding public confidence in the Government; specific proposals include:

- (1) setting up an Economic Stimulation Committee to formulate action plans for post-pandemic economic recovery;

- (4) *strengthening the powers of the 18 District Officers over the administration of the districts so that they can make rapid response and act proactively to address the concerns of the people promptly, in an endeavor to achieve the benefit of 'addressing district affairs at the district level', thereby improving people's livelihood.*
