**Debate and voting arrangements for  
19 motions under Article 73(5) and (10) of the Basic Law or  
the Legislative Council (Powers and Privileges) Ordinance (Cap. 382)**

Members are invited to note that in the 2018-2019 session, the President gave permission for four Members to move, under the captioned Article of the Basic Law and Cap. 382, a total of **four motions** concerning the protest which occurred outside the Legislative Council on 12 June 2019 (“the 612 incident”). The President then directed that two joint debates be held with each covering two of the four motions, and be included in the Agendas for the Council meetings of 3 and 10 July respectively. However, the motions have stood over and have not yet been dealt with by the Council.

2. Since the commencement of the 2019-2020 session, the President has given permission for another **15 motions** to be moved by 11 Members under the captioned Article of the Basic Law and Cap. 382.

3. All of the above **19 motions** concern the protests in Hong Kong in recent months. They may be categorized as follows, based on their key contents:

(a) investigating a single incident, namely:

- (i) the 612 incident (**covered by the four motions mentioned in paragraph 1 above**);
- (ii) the incident of assaults which occurred in Yuen Long Station of West Rail Line of the MTR Corporation Limited (“MTRCL”) on 21 July 2019 (“the 721 incident”) (**covered by two motions<sup>1</sup>**); and

(iii) the incident of assaults which occurred in Prince Edward Station of MTRCL on 31 August 2019 (“the 831 incident”) (**covered by four motions<sup>2</sup>**);

- (b) investigating the Police’s handling of protesters and persons performing duties in the protests during the “anti-extradition to China” movement (**covered by eight motions**); and
- (c) investigating the causes and consequences of the social conflicts or disturbances arising from the amendments to the Fugitive Offenders Ordinance (Cap. 503) and related matters (**covered by two motions**).

4. As the 19 motions are considerable in number, to make effective use of the Council’s time and avoid repetition of arguments, the President has decided that **five joint debates** be held in accordance with the above grouping (including re-grouping the four motions concerning the 612 incident mentioned in paragraph 1 under one joint debate). The details of such debates are in **Appendix 1**.

5. The speaking and voting arrangements for the five joint debates are in **Appendix 2** (Chinese version only). In each joint debate, each Member may only speak once and the time limit is 15 minutes, while the motion movers will have another opportunity to speak again with the time limit also set at 15 minutes before their motions are put to vote. The public officer will not be subject to any speaking time limit. After each joint debate comes to a close, the motions/amendment will be voted upon in accordance with the order set out in Appendix 2.

6. Members are also invited to note that if Members propose further motions with summoning power which concern the protests in Hong Kong in recent months, **the President may adjust the above debate arrangements where appropriate or necessary, such as including such new motions in the above joint debates**. Members will be informed separately by circular if there is any adjustment.
