Preliminary Agenda

Further to the notice of meetings issued under LC Paper No. CB(3) 430/20-21 on 26 March 2021, I now attach the preliminary Agenda for the above meeting, which will be posted on the Legislative Council website.

2. As Members are aware, the above meeting **aims to let Members speak in the Second Reading debate on the Appropriation Bill 2021 (“the Bill”)**. In accordance with Appendix IIIA to the House Rules, each Member **may speak once for a maximum of 10 minutes** in the Second Reading debate. As there will be sufficient time on 21 April 2021 for all Members to speak in the debate, the President **has directed that the above meeting be held in one day only on 21 April at 11:00 am and be adjourned when no more Member indicates the intention to speak.**

3. Members who wish to speak in the Second Reading debate on the Bill are reminded to keep close track of the progress and return to the Chamber on time. Those Members who do not speak on 21 April will not be allowed to speak in the debate. At the third Budget meeting of 28 April 2021, only public officers may speak before the Council goes into committee of the whole Council to consider the Bill.
