Mainland Judgments in Matrimonial and Family Cases (Reciprocal Recognition and Enforcement) Bill Debate and voting arrangements

Objects of the Bill : To give effect to the Arrangement on Reciprocal Recognition and Enforcement of Civil Judgments in Matrimonial and Family Cases by the Courts of the Mainland and of the Hong Kong Special Administrative Region made between the Supreme People's Court of the People's Republic of China and the Government of the Hong Kong Special Administrative Region by providing for:

- (a) the recognition and enforcement in Hong Kong of judgments in matrimonial and family cases given in the Mainland;
- (b) facilitating the recognition and enforcement in the Mainland of judgments in matrimonial and family cases given in Hong Kong;
- (c) the recognition of Mainland divorce certificates; and
- (d) related matters.

Debate theme : The arrangement on reciprocal recognition and enforcement of civil judgments in matrimonial and family cases

SJ's amendments

The extent to which a maintenance-related order given in a Mainland Judgment may be registered in Hong Kong

Clause 11

- To amend clause 11(1) to (3) and delete clause 11(4). The amendments seek to stipulate clearly that, in respect of the registration of a maintenance-related order that requires a payment or an act to be made or performed periodically ("periodic order"), the registering court may order that the registration covers those further payment/act which will become due on or after the application date and have not yet been paid/performed on the date of registration. This means that the judgment creditor may not need to apply to the court for registration of the periodic order again upon further default of such periodic payment/act in future.

Other technical and textual amendments

Clauses 2, 8, 11, 19 and 24, and Schedule 2

- To amend clauses 2, 8(1), 8(2) and 8(3), the headings of clauses 11, 19 and 24, clauses 19(1) and 24(1), and the headings of Parts 1, 2 and 3 of Schedule 2 by replacing "攸關 看顧" with "看顧相關", "攸關贍養" with "贍養相關" and "攸關狀況" with "狀況相關" in the Chinese text for easier understanding by the general public.

Clauses 16, 17 and 26, and Schedules 2 and 3

- To amend items 1, 3 and 4 in Part 1 and item 1 in Part 3 of Schedule 2, and item 12 in Schedule 3 by replacing "子女" in "未滿18歲子女" with "的人" in the Chinese text to connote a broader interpretation to cover *any person under the age of 18 years* not restricting to a party's own "son" or "daughter" under the age of 18 years, and correspondingly replace "a child" in "a child under the age of 18 years" with "a person" in the English text; and make consequential amendments to clauses 16(2), 17(3)(b) and 26(5)(b); and
- To amend item 2 in Part 1 and item 2 in Part 3 of Schedule 2 to make the provisions clearer.
