Debate and voting arrangements for Public Offices (Candidacy and Taking Up Offices) (Miscellaneous Amendments) Bill 2021

Public Offices (Candidacy and Taking Up Offices) (Miscellaneous Amendments) Bill 2021 Debate and voting arrangements

Objects of the Bill:

To amend various Ordinances to provide for matters relating to the requirement of oath-taking by certain public officers when assuming office, including:

- (a) the meaning of a reference to "upholding the Basic Law ("BL") and bearing allegiance to the Hong Kong Special Administrative Region of the People's Republic of China ("HKSAR")" when used in legislation;
- (b) new requirement for members of the District Councils ("DC") to take an oath when assuming office;
- (c) arrangement for administration of public officers' oaths; and
- (d) legal consequences of declining or neglecting to take an oath and of breach of an oath.

SCMA's amendments

Clauses 21 and 26

Debate theme

Arrangements for dealing with corresponding entitlements during suspension of functions and duties

- The Bill proposes to amend section 73 of the Legislative Council Ordinance (Cap. 542) and section 79 of the District Councils Ordinance (Cap. 547) to provide that immediately after proceedings are brought by the Secretary for Justice against a LegCo/DC member on the grounds of the breach of an oath or failure to fulfil the legal requirements and conditions on upholding BL and bearing allegiance to HKSAR, the member's functions and duties will be suspended. In this regard, the amendments seek to:
 - (a) amend clauses 21(2) and 26(2) to add a proposed paragraph (ba) respectively to the proposed section 73(2C) of Cap. 542 and the proposed section 79(2C) of Cap. 547 to specify that the member concerned must not enjoy any corresponding entitlements, which include remuneration, allowances and various kinds of reimbursement for expenses, during the suspension of functions and duties; and
 - (b) amend clauses 21(3) and 26(3) to add a proposed subsection (4AA) respectively to section 73 of Cap. 542 and section 79 of Cap. 547 to specify that a disqualified member ceased to be entitled to any corresponding entitlements from the date of disqualification.

Other technical and textual amendments

- To add clause 26(1A) and amend clause 26(2) to replace "提出" with "提起" in the Chinese text of the heading of section 79 and the proposed section 79(2A) for consistency of wording; and
- to amend the Chinese text of the proposed section 79(2D) in clause 26(2) to improve the drafting.
