Revenue (First Registration Tax and Licence Fees for Motor Vehicles) Bill 2021 Debate and voting arrangements

Object of the Bill:

To amend the Motor Vehicles (First Registration Tax) Ordinance (Cap. 330) and the Road Traffic (Registration and Licensing of Vehicles) Regulations (Cap. 374E) to give effect to proposals concerning first registration tax ("FRT") and licence fees for motor vehicles in the Budget introduced by the Government for the 2021-2022 financial year; and to make a consequential amendment.

Joint debate on the original clauses, amendments and long title.

Debate theme : Commencement of the Ordinance and transitional provisions

Hon SHIU Ka-fai's amendments

First group of his amendments — clauses 1 to 6 and Part 4 (namely clause 7)

- To amend clause 1(2) to defer the commencement of the Ordinance from 11:00 am on 24 February 2021 to 24 February 2022, to delete clause 3, and to make consequential amendments.

Second group of his amendments — long title

- Consequent upon the first group of amendments, to amend the long title.

Hon Frankie YICK's amendments

Clause 3

- To extend the scope of application of the transitional arrangements in relation to the proposed increase of the rates of FRT by adding a provision to the proposed section 12 of Cap. 330, so that FRT rates as in force immediately before the commencement time (i.e. 11:00 am on 24 February 2021) would continue to apply to a private car if the registered distributor or registered importer who is selling the private car could prove to the satisfaction of the Commissioner for Transport that the private car has been shipped on board a vessel for export to Hong Kong on or before 19 March 2021, and to make a consequential amendment.
