**Council meeting of 18 August 2021**

**Motion to take note of Report No. 24/20-21 of the House Committee  
on Consideration of Subsidiary Legislation and Other Instruments**

Hon Starry LEE, Chairman of the House Committee, has given notice under Rule 49E(2) of the Rules of Procedure to move the attached motion to take note of Report No. 24/20-21 of the House Committee in relation to the following eight items of subsidiary legislation at the above meeting:

The President has directed that the motion be printed in the terms in which it was handed in on the Agenda of the Council.

2. The President has decided that the debate on the above motion **be divided into two sessions:**

- (a) the first session is to debate the above subsidiary legislation of item number (1); and
- (b) the second session is to debate the above subsidiary legislation of item numbers (5) to (11) which were scrutinized by the same Subcommittee.

To assist Members in debating the motion, I set out the relevant proceedings under which the President will:

Moving of the motion

- (a) invite the Chairman of the House Committee to move the take-note motion;
- (b) propose the question on the motion;

First debate session

- (c) invite the Chairman of the Subcommittee on Fire Service (Installations and Equipment) (Amendment) Regulation 2021 to speak;
- (d) invite other Members to speak;
- (e) invite the public officer to speak after all Members who wish to speak have spoken (no Member may speak after the public officer has spoken);
- (f) after the public officer has spoken, order that this debate session will come to a close and the second debate session will begin immediately;

Second debate session

- (g) invite the Chairman of the Subcommittee on Seven Pieces of Subsidiary Legislation Relating to the Implementation of the New Inspection Regime of the Companies Register under the Companies Ordinance to speak;
- (h) invite other Members to speak;
- (i) invite the public officer to speak after all Members who wish to speak have spoken (no Member may speak after the public officer has spoken); and
- (j) in accordance with Rule 49E(9) of the Rules of Procedure, after Members and the public officer have spoken on the motion, order that the debate will come to a close and will not put any question.

Speaking arrangement

3. Members are reminded that in accordance with Appendix IIIA to the House Rules, the **maximum duration** of this debate is **2 hours** and each Member **may speak once up to a maximum of 5 minutes in each debate session**. Public officer(s) will not be subject to any speaking time limit.
