## **Crimes (Amendment) Bill 2021 Debate and voting arrangements**

#### **Object of the Bill:**

To amend the Crimes Ordinance (Cap. 200) to provide for new offences of voyeurism, non-consensual recording of intimate parts, publication of images originating from voyeurism or non-consensual recording of intimate parts and publication or threatened publication of intimate images without consent; and to provide for related matters.

# Joint debate : Clauses with no amendment, and a clause and long title with amendments proposed by the Secretary for Security ("S for S")

- Clauses 1 to 3 and the long title

Joint debate on the original clauses, amendments and the long title.

#### S for S's amendments

#### Clause 3

Expanding the definition of an "intimate image" to cover an "altered image"

- To amend the definition of an "intimate image" under the proposed section 159AA(1) to cover an "altered image", i.e. an image that has been altered to appear to show an intimate part of an individual or an individual doing an intimate act.

#### Offence elements of the three new offences

- To amend the proposed sections 159AAB, 159AAC and 159AAD to remove the offence element of "no consent is given by the subject individual" from the proposed offences of voyeurism, non-consensual recording of intimate parts and publication of images originating from voyeurism and non-consensual recording of intimate parts;
- to amend the proposed offence of non-consensual recording of intimate parts in the proposed section 159AAC to provide clearly that one of the offence elements is that the defendant records or operates equipment "dishonestly", and to remove the offence element of "gain";
- to amend the heading of the proposed section 159AAC as "Unlawful recording or observation of intimate parts" to concisely and clearly reflect the nature of the proposed offence; and
- to add subsection (2A) under the proposed section 159AAD to further explain the requisite criminal intent of the proposed offence.

#### New provisions for a disposal order

- To add proposed new Division 4 (Disposal Order) under the proposed Part XIIAA to empower the magistrate to order the defendant or any other persons to remove, delete or destroy intimate images involved in relevant criminal proceedings.

#### Other technical and textual amendments

- Consequent upon the above amendment to the heading of the proposed section 159AAC and the addition of the proposed new Division 4, to amend the heading of the proposed Part XIIAA; and
- to make technical amendments to the Chinese text of the proposed section 159AAB(1)(a)(i) to make it more consistent with the English text.

#### Long title

- Consequent upon the above amendment to the heading of the proposed section 159AAC, to amend the long title.
