<u>Action</u>

Item 1 — Election of Chairman and Deputy Chairman for the 2020-2021 session

Election of Chairman

Mr CHAN Kin-por, the Chairman of the Finance Committee ("FC") in office, presided over the election of the Chairman of FC for the 2020-2021 session.

- 2. Mr CHAN Kin-por was nominated by Mr Jimmy NG and the nomination was seconded by Mr WONG Ting-kwong. Mr CHAN Kin-por accepted the nomination. According to paragraph 6(b) of the Finance Committee Procedure, Mr CHAN Chun-ying, the Deputy Chairman of FC in office, then took the Chair. Mr CHAN Chun-ying asked if there were other nominations. At 5:03 pm, Mr CHAN Chun-ying declared the nomination process ended. A total of 12 valid nominations were received. A detailed nomination list is in Appendix I.
- 3. During the nomination process, after Mr MA Fung-kwok had indicated that he did not accept the nomination for the chairmanship of FC for the 2020-2021 session, and in order to proceed with the nomination procedure more effectively, Mr CHAN Chun-ying said that if there were other members also not accepting nomination, they might so indicate by a show of hands. In this connection, of the members present at the juncture, Mr LAU Kwok-fan, Mr CHEUNG Kwok-kwan, Mr CHAN Hak-kan, Ms Starry LEE, Mr WONG Ting-kwong, Mr POON Siu-ping, Mr Holden CHOW, Ms YUNG Hoi-yan, Mr Christopher CHEUNG, Mr Kenneth LAU, Ir Dr LO Wai-kwok, Mr SHIU Ka-fai, Mr Tommy CHEUNG, Mr WONG Kwok-kin, Dr Junius HO, Mr YIU Si-wing, Mr Martin LIAO and Mr Tony TSE raised their hands to indicate their non-acceptance of nomination for the chairmanship of FC for the 2020-2021 session. Afterwards, in response to nominations made by members, Mr LEUNG Che-cheung, Mr LUK Chung-hung and Ms Elizabeth QUAT also indicated their non-acceptance of the nominations.

(During the nomination process, Mr CHAN Chun-ying ruled certain nominations invalid on the ground that members being nominated did not accept the nominations, or that members making nominations were unable to state that the acceptance of nominations by relevant members not present at the juncture had been secured.)

- 4. Mr CHAN Chun-ying said that, drawing reference from the arrangement for the election of Chairman of the House Committee held earlier on the same day, he considered that members, being experienced Members, were familiar with FC's operation, and that the Chairman's role was mainly to preside over meetings. Therefore, he decided that it was not necessary to hold an election forum. Mr James TO suggested that candidates could be allowed to present their election platforms only. Mr CHAN reiterated the above decision not to hold an election forum.
- 5. At 5:04 pm, Mr CHAN Chun-ying announced a vote by secret ballot. After Secretariat staff had distributed the ballot papers, Mr CHAN

announced that a total of 54 ballot papers were distributed. At 5:08 pm, after members had finished marking the ballot papers, <u>Mr CHAN</u> ordered that ballot papers be collected.

- 6. At 5:11 pm, after receiving an oral report from the Clerk, Mr CHAN Chun-ying announced that 55 ballot papers had been collected indeed. He said that, as reported by the Secretariat, Secretariat staff had wrongly reported the number of ballot papers distributed, and that 55 ballot papers were distributed actually, instead of 54 as announced before. For the sake of prudence, he ordered that a vote by secret ballot be conducted afresh and the distribution of new ballot papers to members present.
- 7. At 5:15 pm, Mr CHAN Chun-ying announced that Secretariat staff had collected 55 ballot papers, same as the number of ballot papers distributed. He invited the nominators of the candidates to come forward to the head table to monitor the counting of votes. Of the 55 members present for voting, 36 voted for Mr CHAN Kin-por and 19 voted for LEUNG Yiu-chung. CHAN Chun-ying declared that Mr CHAN Kin-por was elected as the Chairman of FC for the 2020-2021 session.

Election of Deputy Chairman

- 8. <u>The Chairman</u> called for nominations for the deputy chairmanship of FC for the 2020-2021 session.
- 9. Mr CHAN Chun-ying was nominated by <u>Dr Priscilla LEUNG</u> and the nomination was seconded by <u>Mr KWOK Wai-keung</u>. <u>Mr CHAN Chun-ying</u> accepted the nomination. <u>The Chairman</u> asked if there were other nominations. At 5:33 pm, <u>the Chairman</u> declared the nomination process ended. A total of 12 valid nominations were received. A detailed nomination list is in **Appendix II**.
- 10. During the nomination process, after Mr LUK Chung-hung had indicated that he did not accept the nomination for the deputy chairmanship of FC for the 2020-2021 session, the Chairman said that if there were other members also not accepting nomination, they might so indicate by a show of hands. In this connection, of the members present at the juncture, Mr CHAN Han-pan, Mr LAU Kwok-fan, Mr CHEUNG Kwok-kwan, Mr CHAN Hak-kan, Ms Starry LEE, Mr WONG Ting-kwong, Mr LEUNG Che-cheung, Mr POON Siu-ping, Ms Elizabeth QUAT, Mr Holden CHOW, Mr Steven HO, Mrs Regina IP, Ms YUNG Hoi-yan, Mr Christopher CHEUNG, Mr Kenneth LAU, Ir Dr LO Wai-kwok, Dr Priscilla LEUNG, Mr Frankie YICK, Ms Alice MAK, Dr Junius HO, Mr Martin LIAO, Mr MA Fung-kwok, Mr Jimmy NG, Mr YIU Si-wing,

Mr Vincent CHENG and Mr Tony TSE raised their hands to indicate their non-acceptance of nomination for the deputy chairmanship of FC for the 2020-2021 session. Afterwards, in response to nominations made by members, Mr SHIU Ka-fai, Mr Michael TIEN, Mr Jeffrey LAM and Mr Tommy CHEUNG also indicated their non-acceptance of the nominations.

(During the nomination process, the Chairman ruled certain nominations invalid on the ground that members being nominated did not accept the nominations, or that members making nominations were unable to state that the acceptance of nominations by relevant members not present at the juncture had been secured.)

- 11. <u>The Chairman</u> announced a vote by secret ballot. He invited the nominators of the candidates to come forward to the head table to monitor the counting of votes. Of the 56 members present for voting, 37 voted for Mr CHAN Chun-ying, 18 voted for Mr Andrew WAN and 1 voted for Dr Pierre CHAN. <u>The Chairman</u> declared that Mr CHAN Chun-ying was elected as the Deputy Chairman of FC for the 2020-2021 session.
- 12. The meeting ended at 5:42 pm.
