ITEM FOR FINANCE COMMITTEE

HEAD 184 – TRANSFERS TO FUNDS New subhead "Payment to the Lotteries Fund"

Members are invited to approve the creation of a new subhead "Payment to the Lotteries Fund" under Head 184 Transfers to Funds and a supplementary provision of \$1.1 billion under the new subhead to enable an injection to be made into the Lotteries Fund.

PROBLEM

The revenue of Lotteries Fund (LF) has dropped substantially since the outbreak of Coronavirus Disease 2019 (COVID-19). The Government has to make an injection into LF to ensure that the planning of the much-needed welfare services will not be affected.

PROPOSAL

2. The Secretary for Labour and Welfare proposes the creation of a new subhead "Payment to the Lotteries Fund" under Head 184 Transfers to Funds and a supplementary provision of \$1.1 billion under the new subhead to enable the transfer of additional funds from the General Revenue to LF.

JUSTIFICATION

Financial position of LF

3. The proceeds from the Mark Six Lottery are the main source of recurrent revenue of LF, amounting to an annual average of around \$1.2 billion for the past four years (from 2016-17 to 2019-20), which accounts for more than 50% of LF's recurrent revenue. Other sources of revenue include net proceeds from auctions of vehicle registration marks, investment income and donations. Since the outbreak of COVID-19, the revenue from Mark Six Lottery in 2020-21 dropped

substantially by 76% to \$288 million (revised estimate). While LF's annual total revenue was \$2.1 billion on average in the four years before the pandemic (i.e. from 2016-17 to 2019-20), the total revenue for 2020-21 is expected to be halved (i.e. \$1.1 billion). Details of receipts of LF in the past five years are set out at Enclosure 1.

4. While the revised estimate for the closing balance of LF for 2020-21 stood at \$21.102 billion, the following outstanding commitment (estimated to be around \$12.4 billion as at the end of March 2021) has not yet been taken into account –

- Outstanding commitment pertaining to non-recurrent expenditure for the planned projects spearheaded by the Social Welfare Department (SWD)¹, such as pre-construction consultancy services (including technical feasibility studies (TFS) and detailed design) and construction;
- (b) Outstanding commitment pertaining to non-recurrent expenditure for approved welfare projects undertaken by non-governmental organisations (NGOs), covering mainly the Special Scheme on Privately Owned Sites for Welfare Uses (the Special Sites Scheme)²; and
- (c) Outstanding commitment pertaining to non-recurrent expenditure with regard to existing premises operated by NGOs (e.g. renovation works, repair and maintenance, and procurement/replacement of furniture and equipment (F&E)), etc.
- Encl. 2 Movement of the account of LF in the past five years is set out at Enclosure 2.

5. As announced in the 2021-22 Budget, the Government will make an injection of \$1.1 billion into LF to ensure that development projects in respect of much-needed social welfare services premises, particularly TFS and detailed designs of major facilities for elderly and rehabilitation services, etc., can be taken forward as scheduled. Examples of large-scale development projects of social welfare services premises include the re-development of Wong Chuk Hang

¹ These welfare projects include projects with SWD as the works agent on government sites; and projects entrusted to other agents (e.g. the Hong Kong Housing Authority/Hong Kong Housing Society, Urban Renewal Authority, Architectural Services Department and private developers) for development of welfare facilities in public housing projects, urban renewal projects, joint-user government buildings, private land sale sites/development projects, etc.

² The Special Sites Scheme was announced in the 2013 Policy Address. Under the Scheme, NGO applicants for LF have to provide or increase on their own sites, through expansion, re-development or new development, those welfare facilities in acute demand (i.e. elderly, rehabilitation and child care services).

Complex Site (around 2 500 additional service places), re-development of the Hong Kong Society for Rehabilitation's Lam Tin Complex (around 1 000 additional service places), re-development of Tung Wah Group of Hospitals' Jockey Club Care and Attention Home for the Elderly on Sandy Bay Road (around 1 000 additional service places). Other social welfare services premises development projects which are expected to benefit from the \$1.1 billion injection are at Enclosure 3. Where necessary, we will also flexibly deploy the injected fund as appropriate to support other welfare projects within the ambit of LF.

6. We will closely monitor LF's financial position, including the revenue and expenditure of LF, as well as the financial commitments required of various social welfare services projects. The last injection of \$10 billion was made from the General Revenue into LF in 2013-14 when the Government launched the Special Sites Scheme.

FINANCIAL IMPLICATIONS

7. Subject to the Finance Committee (FC)'s approval of our proposal in paragraph 2 above, a supplementary provision of \$1.1 billion will be included under Head 184 Transfers to Funds in 2021-22 to enable an injection of \$1.1 billion into LF.

PUBLIC CONSULTATION

8. We consulted the Legislative Council Panel on Welfare Services on the proposal on 19 April 2021. Members supported the submission of the proposal to FC.

BACKGROUND

9. Established by Resolution of the Legislative Council in 1965, LF is used for the purpose of financing the support and development of social welfare services in Hong Kong. At present, LF is primarily used to meet the costs of works projects in connection with the welfare services provided by NGOs and the Government, including costs for TFS, detailed design, construction, renovation/repair and maintenance, and procurement/replacement of F&E. LF also provides funding to finance time-limited experimental projects on welfare services.
