12. <u>The Chairman</u> invited Members to note that Dr Junius HO, who was allocated a debate slot for moving a motion at the Council meeting of 8 September 2021, had withdrawn the notice of his motion after the deadline for giving notice of motion. As such, only one motion not intended to have legislative effect moved by Dr Priscilla LEUNG would be dealt with at the meeting. <u>The Chairman</u> reminded Members that the deadline for giving notice of amendments, if any, to the above motion would be Wednesday, 1 September 2021.

# Report of the Subcommittee on Subsidiary Legislation to Regulate the Operation of Small Unmanned Aircraft

14. <u>Mr WONG Ting-kwong</u>, Chairman of the Subcommittee, briefed Members on the deliberations of the Subcommittee as detailed in its report. He said that a majority of the members of the Subcommittee supported the five items of subsidiary legislation (i.e. L.N. 115 to L.N. 119) and that the Subcommittee would not propose any amendments to them.
