3. The House Committee formed four subcommittees to study item (1), items (2) to (4), items (5) to (7), as well as item (8) respectively in detail at its meeting on 16 October 2020. The first Subcommittee made a verbal report at the House Committee meeting on 20 November 2020, and provided Members with a written report vide LC Paper No. CB(2)378/20-21 on 24 November 2020. The second, third and fourth Subcommittees reported their deliberations at the House Committee meeting on 20 November 2020 vide LC Paper Nos. CB(1)233/20-21, CB(1)234/20-21 and CB(2)335/20-21 respectively.

4. A subcommittee was proposed to be formed to study item (9) in detail at the House Committee meeting on 6 November 2020. Since only one Member has signified to join the proposed subcommittee by the deadline for signification of membership, it cannot be formed by virtue of rules 21(b) and 26(f) of the House Rules.
