Report No. 24/20-21 of the House Committee on Consideration of Subsidiary Legislation and Other Instruments

Purpose

This report gives the outcome of the consideration of the House Committee on subsidiary legislation the period for amendment of which will expire at the Council meeting of 18 August 2021.

Subsidiary legislation considered

2. The House Committee has considered the following items of subsidiary legislation:

3. The House Committee formed two subcommittees to study item (1) and item (2) respectively in detail at its meeting on 11 June 2021. The former Subcommittee made a verbal report at the House Committee meeting on 16 July 2021, and provided Members with a written report vide LC Paper No. CB(2)1332/20-21 on 23 July 2021. The latter Subcommittee reported its deliberations at the same House Committee meeting vide LC Paper No. CB(1)1118/20-21.

4. The House Committee formed two subcommittees to study items (3) and (4), as well as items (5) to (11) respectively in detail at its meeting on 25 June 2021. The two Subcommittees made verbal reports at the House Committee meeting on 16 July 2021, and provided Members with written reports vide LC Paper Nos. CB(1)1150/20-21 and CB(1)1183/20-21 on 28 July and 5 August 2021 respectively.

5. At the House Committee meeting on 25 June 2021, the House Committee agreed that items (12) and (13) should be studied by the Subcommittee on Subsidiary Legislation Relating to the Prevention and Control of Disease which had been formed at the House Committee meeting on 16 October 2020. The Subcommittee made a verbal report at the House Committee meeting on 16 July 2021, and provided Members with a written report vide LC Paper No. CB(4)1322/20-21 on 9 August 2021.

6. In respect of items (14) to (17), the House Committee considered it not necessary to form any subcommittee to study these four items of subsidiary legislation.

Note: The House Committee formed a subcommittee to study the following five items of subsidiary legislation at its meeting on 23 July 2021. Hon WONG Ting-kwong, Chairman of the Subcommittee, has given notice to move a proposed resolution at the Council meeting of 18 August 2021 to extend the period for amending these five items of subsidiary legislation to the Council meeting of 8 September 2021.
