## Report No. 23/20-21 of the House Committee on Consideration of Subsidiary Legislation and Other Instruments

## **Purpose**

This report gives the outcome of the consideration of the House Committee on subsidiary legislation the period for amendment of which will expire at the Council meeting of 21 July 2021.

## Subsidiary legislation considered

2. The House Committee has considered the following items of subsidiary legislation:

- 3. The House Committee considered it not necessary to form any subcommittee to study these seven items of subsidiary legislation.

- (b) At the House Committee meeting on 25 June 2021, the House Committee agreed that the following two items of subsidiary legislation should be studied by the Subcommittee on Subsidiary Legislation Relating to the Prevention and Control of Disease which had been formed at the House Committee meeting on 16 October 2020. The Council passed at its meeting of 14 July 2021 a resolution moved by Dr Hon CHIANG Lai-wan, Chairman of the Subcommittee, to extend the period for amending these two items of subsidiary legislation to the Council meeting of 18 August 2021. Details are as follows:

- (c) The House Committee formed a subcommittee to study the Financial Institutions (Resolution) (Contractual Recognition of Suspension of Termination Rights—Banking Sector) Rules (L.N. 106/2021) at its meeting on 2 July 2021. The President has given permission for Hon Holden CHOW, Chairman of the Subcommittee, to move a proposed resolution at the Council meeting of 21 July 2021 to extend the period for amending this item of subsidiary legislation to the Council meeting of 25 August 2021.
- (d) The House Committee formed a subcommittee to study the Peak Tramway (Safety) (Amendment) Regulation 2018 (Commencement) Notice (L.N. 110/2021) at its meeting on 16 July 2021. Hon Starry LEE, Chairman of the House Committee, has given notice to move a proposed resolution at the Council meeting of 21 July 2021 to extend the period for amending this item of subsidiary legislation to the Council meeting of 1 September 2021.
