### **Report No. 6/20-21 of the House Committee on Consideration of Subsidiary Legislation and Other Instruments**

#### **Purpose**

This report gives the outcome of the consideration of the House Committee on subsidiary legislation the period for amendment of which will expire at the Council meeting of 16 December 2020.

3. The House Committee considered it not necessary to form any subcommittee to study these nine items of subsidiary legislation.

*Note: At the respective House Committee meetings on 27 November 2020 and 4 December 2020, the House Committee agreed that the following three items of subsidiary legislation should be studied by the Subcommittee on Subsidiary Legislation Relating to the Prevention and Control of Disease which had been formed at the House Committee meeting on 16 October 2020. Dr Hon CHIANG Lai-wan, Chairman of the Subcommittee, has given notices to move two proposed resolutions at the Council meeting of 16 December 2020 to extend the period for amending these three items of subsidiary legislation to the Council meetings of 13 January 2021 and 20 January 2021 respectively. Details are as follows:*
