- 3. At the House Committee meeting on 27 November 2020, the House Committee agreed that items (1) and (2) should be studied by the Subcommittee on Subsidiary Legislation Relating to the Prevention and Control of Disease which had been formed at the House Committee meeting on 16 October 2020. The Subcommittee provided Members with a written report vide LC Paper No. CB(2)563/20-21 on 29 December 2020, and reported at the House Committee meeting on 8 January 2021 its deliberations on items (1) and (2) as well as 12 other items of subsidiary legislation tabled in Council between 18 November 2020 and 9 December 2020.
- 4. Regarding items (3) to (5), Members were consulted on whether they considered it necessary to form a subcommittee(s) to study any of these three items of subsidiary legislation vide LC Paper No. CB(2)535/20-21 issued on 17 December 2020.
