At the House Committee meeting on 11 December 2020, the House Committee agreed that items (1) to (11) should be studied by the Subcommittee on Subsidiary Legislation Relating to the Prevention and Control of Disease which had been formed at the House Committee meeting on 16 October 2020. The Subcommittee reported at the House Committee meeting on 8 January 2021 vide LC Paper No. CB(2)563/20-21 its deliberations on items (1) to (10) and four other items of subsidiary legislation tabled in Council between 18 November 2020 and 2 December 2020.
