At the House Committee meeting on 8 January 2021, the House Committee agreed that item (1) should be studied by the Subcommittee on Subsidiary Legislation Relating to the Prevention and Control of Disease which had been formed at the House Committee meeting on 16 October 2020. The Subcommittee made a verbal report at the House Committee meeting on 29 January 2021, and provided Members with a written report vide LC Paper No. CB(4)526/20-21 on 17 February 2021.
