I. Election of Chairman

Election of Chairman

Mr Abraham SHEK Lai-him, the member who had the highest precedence in the Council among members of the Subcommittee on three pieces of subsidiary legislation relating to fees payable for marine fish culture licences and renewal of livestock keeping licences present at the meeting, presided over the election of Chairman of the Subcommittee. He invited nominations for the chairmanship of the Subcommittee.

2. Mr Abraham SHEK Lai-him nominated Mr Steven HO Chun-yin and the nomination was seconded by Dr KWOK Ka-ki. Mr HO accepted the nomination.

3. Mr Abraham SHEK Lai-him invited other nominations for the chairmanship. As there was no other nomination, Mr SHEK declared that Mr Steven HO Chun-yin was elected the Chairman of the Subcommittee. Mr HO then took over the chair.

4. Members agreed that there was no need to elect a Deputy Chairman.

5. The Subcommittee deliberated (index of proceedings in the **Appendix**).

II. Any other business

6. Noting the legislative timetable, members agreed that the Chairman should move a motion at the Council meeting of 4 November 2020 to extend the scrutiny period to the Council meeting of 2 December 2020.

7. Members agreed to invite written submission from members of the public on their views on the three pieces of subsidiary legislation. A public hearing could also be arranged on a need basis.

8. The Chairman said that the next meeting would be scheduled as soon as possible.
