**I. Election of Chairman**

Election of Chairman

Mr James TO Kun-sun, the member who had the highest precedence in the Council among members of the Subcommittee on five pieces of subsidiary legislation on fee waiving and concession measures relating to the tourism and entertainment sectors present at the meeting, presided over the election of Chairman of the Subcommittee.
