#### I. Election of Chairman

Mr CHAN Kin-por, the member of the highest precedence among members of the Subcommittee present at the meeting, presided over the election of Chairman of the Subcommittee. He called for nominations for the chairmanship of the Subcommittee.

- 2. Mr CHAN Chun-ying nominated Mr CHAN Kin-por and the nomination was seconded by Mr YIU Si-wing. Mr CHAN Kin-por accepted the nomination. As Mr CHAN Kin-por was nominated for the chairmanship, Mr YIU Si-wing, the member of the second highest precedence among members present at the meeting, presided over the election of Chairman.
- 3. As there was no other nomination, <u>Mr YIU Si-wing</u> declared Mr CHAN Kin-por elected as the Chairman of the Subcommittee. <u>Mr CHAN Kin-por</u> then took the chair.

- 8. <u>The Chairman</u> concluded that the Subcommittee had completed the scrutiny of the Commencement Notice, and raised no objection to the Commencement Notice. <u>Members</u> would not propose any amendments to the subsidiary legislation.

#### III. Any other business

9. <u>Members</u> noted that the scrutiny period of the Commencement Notice had been extended to 1 September 2021 and the deadline for giving notice of a motion to amend the subsidiary legislation was 25 August 2021.

10. <u>The Chairman</u> said that he would, on behalf of the Subcommittee, make a verbal report on the deliberations of the Subcommittee at the meeting of the House Committee on 20 August 2021 and the written report would be submitted afterwards.
