- 5. <u>Members</u> agreed that the Chairman would move a motion at the Council meeting of 7 July 2021 to extend the scrutiny period of the Amendment Regulation to the Council meeting of 18 August 2021. <u>Members</u> noted that if the scrutiny period was extended, the deadline for giving notice of amendment, if any, was 11 August 2021.
